To the Honorable the Legislature:

As requested by the Joint Legislative Audit Committee, we have completed a statistical analysis of the rates at which inmates released on parole before serving full sentences in the state correctional system are reincarcerated for committing new offenses.

By statute, inmates not serving life sentences become eligible for parole after serving 25 percent of their sentences or six months, whichever is greater. Inmates must be released at two-thirds of their sentences, unless they have committed violations while in prison. We compared incarceration experience and recidivism rates for inmates convicted of violent crimes with those committing other, less-serious offenses. It should be noted, however, that any offense for which the sentence is incarceration in the state correctional system carries some significant degree of seriousness.

Fewer inmates are serving until their mandatory release dates of two-thirds of the sentence, and the percentage released through discretionary parole has increased. Of inmates sentenced for violent crimes, those released between 1983 and 1985 served an average of 58.3 percent of their sentences, whereas those released between 1992 and August 1993 served an average of 53.3 percent of their sentences. The percentage of time served by inmates committing less-serious offenses dropped from 64.5 percent to 53.4 percent of their sentences during the same period.

Violent offenders released between 1980 and 1989 had a higher recidivism rate, 33.6 percent, than less-serious offenders, 28.4 percent. In addition, our analysis indicates that inmates who were judged by the State Parole Commission to be the best risks for early release did have lower recidivism rates than those judged to be poor risks.

We appreciate the courtesy and cooperation extended to us by the Parole Commission and staff of the Department of Corrections.

To the Honorable the Legislature:

As required by s. 115.38, Wis. Stats., I am transmitting the 1992-93 School Performance Report. Under the law, school districts are required to prepare and distribute reports to parents and guardians by January 1 of each year, and the State Superintendent of Public Instruction is required to prepare a statewide summary and submit it to the legislature on an annual basis.

Wisconsin law divides information in the School Performance Report into three categories:

- * Indicators of academic achievement, including results of the Third Grade Reading Test, the Advanced Placement examination, and the Enhanced ACT.
- * Other indicators of school and district performance, including information about dropouts, attendance, retention in grade, graduation, suspensions, expulsions, participation in extra-/co-curricular and school-sponsored community activities, advanced course work, and postsecondary intentions.
- * Staffing and financial information to be determined by the state superintendent.

Although the information contained in this report is an important element of educational accountability, it is not a complete picture. The School Performance Report is a starting point for the public discussion that is vital to understanding students and schools.

The efforts of many people throughout the state made the 1992-93 School Performance Report an excellent collection of statistics and information. Those same people will continue to work on this project in the months and years ahead. It is my hope that, as we link the data to Wisconsin's educational goal, this document will become a tool to measure the efforts of young people and schools.

Pursuing educational excellence is a long journey. If we are to persevere and stay the course, we must be child-centered. We need to work as a community, and we need to be aware of the successes and the problems we will confront along the way. Hopefully, the School Performance Report will help illuminate that journey.

Attached is the First Edition of the Registry of Records Series Containing Personally Identifiable Information as defined in S. 19.62 (5) Wis. Stats. The Public Records and Forms Board is required by S. 16.61 (3)(u), Wis. Stats. to create this registry.

Per s.16.61 (3)(u), Wis. Stats., the registry is designed to:

- * Ensure that state agencies are not maintaining any secret record series containing personally identifiable information;
- * Be comprehensible to an individual using the registry so that identification of records series maintained by state agencies that may contain personally identifiable information about the individual is facilitated; and
- * Identify who may be contacted for further information.

The First Edition contains information for those state agencies identified on pages iv-vi. The remainder of the agencies will be added in other subsequent editions to be issued in the future. After all the agencies that have reported are included, I anticipate that the entire Registry will be reprinted as necessary to reflect changes in agency records series, the individuals identified as contacts and better identification by agencies for those records series that contain personally identifiable information.

I trust that the Registry will succeed in meeting the stated statutory objectives by providing an index and pointing people in the right direction to obtain additional information about personally identifiable information in the State of Wisconsin.
