During this time period, the Department has conducted two Environmental Assessments associated with facilities projects at our institutions, but neither of these required continuation into a full Environmental Impact Statement process.

Mendota Mental Health Institute Construction of a 40bed addition to Lorenz Hall for secure adolescent treatment units, as authorized by the 1991-93 and 1993-95 biennial budgets.

Juvenile Female Development Center Remodeling an existing building at Southern Wisconsin Center to accommodate the new juvenile facility, as authorized by the 1993-95 biennial budget.

To the Honorable the Legislature:

This report is transmitted as required by sec. 20.002(11)(f) of the Wisconsin Statutes, (for distribution to the appropriate standing committees under sec. 13.172(3) Stats.) and confirms that the Department of Administration has found it necessary to exercise the "temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative balances during the month of August, 1994.

On August 1, 1994 the Wisconsin Health Education Fund balance was \$-50 thousand. The shortfall continued until August 10, 1994 when the balance reached \$27 thousand. The shortfall was due to the timing of receipts to the fund.

On August 18, 1994 the <u>Health Insurance Risk Fund</u> balance was -\$2 thousand. This shortfall is also due to the timing of receipts to the fund.

The Wisconsin Health Education Fund and Health Insurance Risk Fund shortfalls were not in excess of the \$400 million ceiling and did not exceed the balances of the Funds available for interfund borrowing.

The distribution of interest earning to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by State Finance will automatically reflect the use of these temporary reallocations of balance authority.

Senate Bill 44 requires the Department of Natural Resources to contract with a person from outside the Department to review the Department's policy and procedures for contracting for work related to environmental cleanups.
