State of Wisconsin Department of Administration Madison

To the Honorable the Legislature:

This report is transmitted as required by sec. 20.002(11)(f) of the Wisconsin Statutes, (for distribution to the appropriate standing committees under sec. 13.172(3) Stats.) and confirms that the Department of Administration has found it necessary to exercise the "temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative balances during the month of September, 1994.

On September 1, 1994 the <u>Health Insurance Risk Fund</u> balance was \$-4 thousand. The shortfall continued through September 30, 1994. This shortfall is due to the timing of receipts to the fund.

The Health Insurance Risk Fund shortfall was not in excess of the \$400 million ceiling and did not exceed the balances of the Funds available for interfund borrowing.

The distribution of interest earning to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by State Finance will automatically reflect the use of these temporary reallocations of balance authority.

State of Wisconsin Legislative Audit Bureau Madison

To the Honorable the Assembly:

We have completed a financial and compliance audit of the University of Wisconsin System as required by s. 13.94, Wis. Stats. and as requested by the University of Wisconsin System Administration to meet the audit requirements of federal Office of Management and Budget Circular A-133. Our audit covers the period July 1, 1991 through June 30, 1993.

Our compliance report (94-20) contains the independent auditor's reports on the internal control structure and on compliance. It also identifies our concerns with controls, instances of noncompliance with federal requirements and questioned costs totaling \$203,366. A separate financial report (94-21) contains the University of Wisconsin System financial statements and supplementary schedule of federal awards and our reports on the statements and schedule for the audited period.

Our reports are lengthy and detailed. We are, therefore, limiting our initial distribution to those required by law to receive copies and to those who have an obvious and direct interest in our detailed findings.
