The senate proceeded in a body to the Assembly Chamber to meet in Joint Convention to receive the State of the State Message.

#### IN ASSEMBLY CHAMBER IN JOINT CONVENTION

The President of the Senate in the chair.

The committee to await upon the Governor appeared with his excellency the Governor, who delivered his message as follows:

President Risser, Speaker Kunicki, Members of the Legislature, Tribal Chairmen, Distinguished Guests, Constitutional Officers ... and a very special greeting to Dr. Bert Grover, our outgoing Superintendent of Public Instruction, who has served us so well for so many wonderful years.

My fellow Wisconsinites:

This is a time of great moment for America. A time to define ourselves in a world suddenly changed ... Where the global map is being re-drawn, re-thought, and reinvented. Where boundaries that divide countries are becoming invisible, and walls that divide people have become rubble -- a souvenir to yesterday.

In this very different world, the sons and daughters of America risk their lives to feed a starving child in Somalia. And in our very changing country, we begin again to imagine a life for ourselves here at home.

Last Wednesday, at 12 o'clock noon to be precise, the Power of the American Presidency moved gracefully,

almost silently, from one hand to another. Even from one generation to another.

And you might have noted as I did, that President Clinton delivered his inaugural address looking west from the capitol, a break from tradition begun twelve years ago as a symbol in itself as to where America's destiny lies.

And that destiny lies here -- in the heart of Wisconsin -- where the American Dream still thrives and flourishes.

Last Wednesday, two very prominent Wisconsinites, Les Aspin and Donna Shalala stood by his side. Now this Governor, this Legislature and all of Wisconsin are partners in the America we will rebuild together.

I am proud to offer Wisconsin as a "Blueprint for Tomorrow." A Blueprint every Legislator in this chamber helped to write. The nation need look no further for the inspiration it needs to succeed.

The change America seeks need not be put off for another day. It is already six years young in Wisconsin.

For six years, we created jobs while our sister states were losing theirs.

For six years, we worked to improve education and have become innovators in giving even the poorest child a chance to choose and be lifted out of hopelessness.

For six years, we challenged the welfare system, with new standards and "Tough Love" and watched our people find for themselves a life worth living.

And while the cloud of deficits hung drearily across much of America, Wisconsin met its obligations ... Without raising taxes, without cutting programs ... Without throwing people out of work, without breaking promises to our citizens.

Why is Wisconsin so special? Why do we succeed while so many others fail? Is it because our people have more character, our leaders more vision? Is it because the values of hard work, individual responsibility, strong families and free markets thrive here like nowhere else?

Or is it a combination of all these things plus one special ingredient: The courage to be creative. To dream what might be, to give that dream form and discipline, to stand firm against the cynics of the status quo, and make something really happen. This is why Wisconsin works. This is why we can inspire all of America to work.

Yes, we are impatient for progress. And yes, our budget is very, very tight.

And to remain fiscally sound, to keep our economy on track ... We're going to have to make some very tough decisions. But we have a history to build on.

A history of bringing business here and not driving it away. While some doors have closed, many more have opened. As a result, there are more people working in Wisconsin today than ever before. Over 285,000 jobs created in the last six years. A business climate that found us creating more manufacturing jobs last year than any other stat. A construction industry enjoying its sixth straight record-setting year. Home building up 23 percent and home sales going through the roof.

For 58 consecutive months, our unemployment rate has been below the national average and our optimism and confidence for the future are second to none.

Over the past five years, more than 10,000 new businesses have incorporated here. And many, like Briggs and Stratton, Harley Davidson, Fi-Serv and the Marcus Corporation, to name but a few, are Re-Incorporating here at home.

And while Wisconsin business is coming home, and staying home our horizons aren't limited to our state or even our country.

In the first three quarters of 1992, our exports were up 17 percent ... And we are on track to beat last year's record-setting \$6 billion dollars in foreign trade. Look at it this way. Every one billion dollars in trade translates into over 20,000 good-paying jobs for Wisconsin.

With Mexico alone, in a single year, we increased our exports 83 percent. Last month, on our largest and most successful trade mission to that country, we were able to lay the foundation for deals in everything from milking equipment to Christmas trees. Considering what we brought back, some people say I should spend more time there.

In Wisconsin, we are partners with business and we know that one person ... One business ... Can make a difference.

Michael Cudahy is taking a million dollars out of his own pocket to put computers in classrooms around Wisconsin.

And William Schuett and Security Bank of Milwaukee have allocated \$35 million for home loans in the central city

Of course, when we talk about business, we should not leave out the business of running government. Making every dollar count. Saying "yes" to loans to help small business get started in our inner cities and rural areas.

Saying "yes" to exciting new industries like Fiber Optics that are linking classrooms throughout Wisconsin. "Yes" to helping minority businesses get started. "Yes" to our Job-Ride Program that provides transportation to people that have found work, but lack the means to get there.

But when it comes to new taxes, my answer is always going to be the same:

A resounding "No."

Do you know where the most exciting things happening in Wisconsin are? They're happening in education.

Our "School Choice" program has given over 600 children from Milwaukee's inner city a chance to go to schools where they want to go, and where they want to learn. And I want to expand school choice to give that opportunity to twice as many children.

We asked ourselves, "Why should only the rich or the well-off have a choice?" And the answer came back loud and clear: Quality education should not be a privilege. It should be a right, a commitment to excellence for every child.

We asked ourselves, "Do our schools really prepare the 70 percent of students who aren't going to get a college degree?"

We came up with two innovative answers. We call on "School-to-Work/Tech Prep," and initiative where we focus on the needs of the job force and give our students the courses and training they'll need to compete.

We call the other "Youth Apprenticeship." Based on the German model, youth apprenticeships give students the opportunity to start preparing for a career while they're still in high school. All eighteen of them are here with us today ... From West Bend and the Fox Valley. Will you please welcome our youth apprentices?

When these students graduate, they will have a high school diploma, a skill in demand, an open door to a meaningful job anywhere in the country. But I hope they stay in Wisconsin.

Our first apprenticeship program taught students to be printers. Next year, I hope to expand this to many other career opportunities.

Now what School-to-Work, Tech-Prep and Youth Apprenticeship mean to education, Workfare and Learnfare mean to people who want to get off welfare.

Let me tell you a secret about most people who are on welfare. They don't like it one little bit. Most want to work. Most want to be independent. And we're helping them get there by the thousands every year.

One such person is Janie Brown. Janie worked her way off welfare ... And through one of our programs, was able to buy her own home. I asked Janie to be here today ... But she said her job came first.

Do you realize our caseload for Aid to Families with Dependent Children is at its lowest level in two years ... Down seventeen percent in six years ... Even though welfare rolls are skyrocketing across America?

That our Workfare program serves as the model for the whole nation to follow? That our child support program

is now second in the nation with an 87 percent increase in collections over five years?

With your support, we're going to get after those delinquent dads who somehow think they can just walk away. My budget will contain the toughest child support collection law ever advanced in Wisconsin. Let's see them walk away from that.

Then there's Learnfare, a program of encouragement for teenagers on welfare to stay in school. Its purpose is not to penalize, but to inspire. Even a not-very-conservative magazine like Newsweek applauds its results.

But Newsweek never said it any better than a recent graduate of Learnfare did in a ceremony honoring thirty-four Learnfare graduates for completing high school in Racine County. He said, "I was so proud to walk across the stage, I wanted to do it six times." That student now plans to go on and become the first member of his family to earn a four year degree.

With us today is the Administrator of this successful program ... Racine County Learnfare Administrator ... Bill Adams. Let's hear it for Bill.

I want to talk about another kind of welfare -- the welfare of our lands, our water, the air we breathe. Protecting nature is second nature in Wisconsin. It's not an attitude we took up in the last few years once it became fashionable. Conservation is at the very root of Wisconsin's soul.

Driving the economy, while still protecting the environment, is not mutually exclusive. We know it because we've done it.

We've done it by passing some of the strongest clean air and clean water laws in America. We've done it by developing new technologies. We've done it by developing research into alternative fuels. We've done it by recycling.

As we speak, a Wisconsin firm is providing recycled paper products for use in Indiana and Michigan, as well as in Wisconsin. While others dawdle, Wisconsin is on the cutting edge of alternative fuels research and technology.

Our Wisconsin energy initiative is making energy conservation count in state facilities. New programs to clean up our watersheds and make our drinking water safer will be introduced in my budget. And I take great personal satisfaction in helping to found the Great Lakes Protection Fund ... And announce with pride that our friends in Canada have now joined our partnership.

The secret to success in Wisconsin is Planning Ahead. It's why we're getting so many federal dollars to build our roads and our highways. Midwest Living magazine calls Wisconsin roads the best in the region.

And it's not only building roads that's getting the attention. It's the fact that our roads were safer last year than they've been since 1945. No other state matched

Wisconsin in lowering the fatality rate. We've increased the use of safety belts to a record 59% -- our goal is to see that number rise to 75% in the next two years.

And some of the toughest drunk driving laws in the country went into effect 26 days ago in Wisconsin.

But it's not just roads that link Wisconsin. I want to expand Amtrak service through the Fox Valley to Green Bay and to Madison.

I am directing the Wisconsin Department of Transportation to invest six hundred thousand dollars in engineering studies for these two routes. I know you're with me on this.

We've pointed to a lot of special people here today. Now let me point to some others who are something special from Wisconsin ... Wisconsin farmers ... The top producer of milk, butter, cheese and ginseng in all America.

Like you, I'm more determined than ever to help our farmers find new technologies and new markets. That's what the New World Dairy and Agriculture Center are all about.

We're not perfect. While we've made progress in encouraging employers to provide health care for their workers, rewriting insurance laws, and expanding access ... We have not reached our goal of health care for all.

But, we have a lot more to do ... Which is why I am bringing the different groups with a stake in health care to the table ... So we can roll up our sleeves and find a way to provide all Wisconsin citizens with quality health care at a price they can afford.

No, we're not perfect. We are still concerned that even our tough laws on crime aren't keeping drugs off our streets and guns out of our classrooms.

And while we've got tougher drug laws ... More officers on the street ... New and specialized drug and homicide courts ... And while our crime rate is 22 percent below the national average ... It's not enough when a mother loses a child over a piece of clothing or a family loses a loved one due to the drunken carelessness of another.

But we will prevail. Health care for all will happen. All our neighborhoods and all our schools will be made safe again.

And we will limit the spread of gambling in Wisconsin once and for all. I ask the legislature to act on the amendment today ... And let the people decide.

If I could accomplish just one thing in the next two years, that one thing would be to control property taxes. Next week, I will be forwarding to you a fresh approach to property tax relief and funding for our schools ... Something that has never been tried before.

But I won't be able to do it alone. I'll need the help of every legislator in this chamber. Ladies and gentlemen,

let us come together, put the past behind us, and find the way to control property taxes.

If there is one thing we learned from the 1992 election, it's that people want us to work together to solve our problems.

We did it with transportation ... We did it with education ... We did it with welfare.

We've done it before, and we will do it again.

Just remember. We're Wisconsin — and that says it all.

Where else in America can a family earning seventeen thousand dollars a year even think about owning a home? You know the answer: Only in Wisconsin.

Where else in America can a poor child from the inner city even think about going to a private school? You know the answer: Only in Wisconsin.

And where else in America can a welfare mother even think that her life of dependency and despondency can be transformed overnight? You know the answer: Only in Wisconsin.

Just remember, we're Wisconsin — and that says it all.

So look to Wisconsin, Mr. President. We're her for you. To help America rediscover itself. To set the example. To lead. To let the whole world know that America is not only coming back, but with Wisconsin in the lead, we're coming back all the way.

ETHICS BOARD

To the Honorable the Senate:

At the direction of § 13.685(7), Wisconsin Statutes, I am furnishing you with the names of organizations recently registered with the Ethics Board as employing one or more individuals to affect state legislation or administrative rules. For each organization I have noted the general area of legislative or administrative action which the organization has described as the object of its lobbying activity and the name of each licensed lobbyist that the organization has authorized to act on its behalf.
