In accordance with s. 196.795(7)(ar), Wis. Stats., the Commission hereby submits the attached report to the Legislature regarding Wisconsin Power and Light Company (WPL). The report discusses the impact of WPL Holdings, Inc. (Holdings) on its public utility affiliate, WPL, as well as the nature of the business of each nonutility affiliate.

We have also enclosed a copy of our 1991 audit report on Holdings. The overall purpose of the holding company audit was to review the operations of WPL and Holdings, and affiliated transactions for compliance with 1985 Wisconsin Act 79.

Finally, we have included a report submitted to the Public Service Commission of Wisconsin by WPL which describes in more detail the activities of the nonutility affiliates, and a two page letter prepared by WPL in response to the report to the Legislature and the 1991 audit report.

To the Honorable the Legislature:

We have completed an audit of the Local Government Property Insurance Fund, which provides property insurance to local units of government and is administered by the Office of the Commissioner of Insurance. As required by s. 13.94, Wis. Stats., we audited and are able to provide and unqualified auditor's report on the Fund's financial statements for the past three fiscal years. We also reviewed the Property Fund's surplus and its contractual arrangements.

The Property Fund accumulated a surplus of \$20.5 million as of June 30, 1992, largely because of actions the Office took to alleviate insurance industry concerns that the Property Fund was unfairly competing with private insurers. The actions included charging higher premiums to avoid severely underpricing private insurers and discontinuing a past practice of issuing dividends.

The current surplus has been the subject of much debate since the Governor attempted to transfer part of the surplus to the State's General Fund in Act 269, Laws of 1991. Based on various measures, we believe a \$10 million surplus is sufficient to meet the Property Fund's present needs. We also believe that the Fund's competition with private insurers is unavoidable. Therefore, we recommend the Office evaluate the feasibility and cost of various options for reducing the surplus, such as reducing rates and resuming dividends.

We also recommend the Office improve its procurement procedures for the Property Fund's administration and reinsurance contracts in order to better justify its award decisions, and that it prohibit the same firm from holding both contracts because of potential conflicts of interest.

We appreciate the courtesy and cooperation extended to us by the management and staff of the Office of the Commissioner of Insurance and the private firms responsible for the administration of the Property Fund. A response from the Office of the Commissioner of Insurance is the appendix.
