State of Wisconsin Legislative Audit Bureau February 26, 1993

To the Honorable the Legislature:

We have completed a financial audit of the State of Wisconsin Unemployment Reserve Fund for the years ended June 30, 1992, and June 30, 1991. We performed the audit at the request of the Department of Industry, Labor and Human Relations and to meet our audit responsibilities under s. 13.94, Wis. Stats.

The adjusted cash balance in the Reserve Fund on the Schedule of Adjusted Cash Balance Related to Taxable Employers decreased \$4.4 million during the past fiscal year, to \$1.143 billion. Because this cash balance was still

in excess of \$1 billion, the lowest tax rate schedule will continue to be in effect, at least through calendar year 1993.

Our audit report contains the auditor's unqualified opinion on the financial statements and related footnotes, as well as on the Schedule of Adjusted Cash Balance Related to Taxable Employers and related footnote.

We appreciate the courtesy and cooperation extended to us by department staff during the audit.
