To the Honorable the Legislature:

We are pleased to send you our report pursuant to s. 196.195(11), Stats., and nonstatutory Section 42, paragraph 2, of 1989 Wisconsin Act 344. This report provides a history of the evolution of the telecommunications industry and the regulation of that industry in the state of Wisconsin.

The industry has changed significantly in the last six years, and will continue to change even more in the future. Not only has the number of services offered increased, but so has the number of providers.

The Commission will continue to review the changes in the industry and, when consistent with the protection of ratepayers and with other public interest goals established by the legislature, rely on competition rather than regulation to determine the variety, quality and price of telecommunications services.

The 60-day extension allowed our most recent decisions on toll competition, carrier access charges, lifeline rates for low income customers and fiber optic cable sizing to be reflected in the report. Also, it allowed us to obtain additional comments on the report from interested parties before submission.

As required under Section 301.03(6r) of the Wisconsin Statutes I am submitting information relative to the number of prisoners the Department of Corrections considers violent and the total number of prisoners.

On December 31, 1992 the Department had 8,054 adult inmates under institution supervision. Out of the 8,054 adult inmates 5,631 (70%) had assaultive offenses.
