To the Honorable the Legislature:

We have completed a financial audit and program evaluation of the State of Wisconsin Lottery Board to meet our audit requirements under s. 13.94(1)(em), Wis. Stats. and as requested by the Lottery Board to meet its requirements under s. 565.37(1), Wis. Stats. The Lottery Board, which was created in December 1987, was replaced by the Gaming Commission on October 1, 1992.

The Wisconsin Lottery has provided almost \$419 million of property tax relief since its inception, including over \$236 million in fiscal year (FY) 1991-92. However, primarily because large carry-over balances of unspent lottery proceeds are no longer available, the amount available in future years will be significantly less than in prior years.

In FY 1991-92, the Lottery Board had ticket sales of \$449.1 million, representing an increase of almost 15 percent over the previous fiscal year. The percentage of lottery revenue returned to players has been gradually increasing since the Lottery's inception, in order to maintain player interest and to increase sales. However, ticket sale trends to date in FY 1992-93 indicate that the rate of growth may be slowing.

Our program evaluation focused on the extent to which steps have been taken to address concerns raised during previous audits of the Lottery Board, particularily in the areas of personnel management and security. We found that the Lottery Board has been generally successful in taking actions to address the identified concerns. However, it is likely that recent events related to disclosure of the collection of retailer fees and the manipulation of encumbrances, as described in our report 93-2, and the recent decision to contract with a private company to deliver some lottery tickets to retailers have had an effect on employe morale. It will be important for the Gaming Commission to ensure continuity of effort to address morale concerns by establishing a plan to address identified employe concerns.

We appreciate the courtesy and cooperation extended to us by the Lottery Board staff. The response from the Gaming Commission is Appendix IV.
