To the Honorable the Legislature:

We have completed an evaluation of instructional workload within the University of Wisconsin (UW) System as requested by the Joint Legislative Audit Committee. In addition to their teaching responsibilities, faculty have research and public service responsibilities.

The University reported in October 1992 that average faculty teaching loads had not changed significantly since 1981. We found, however, that this conclusion overlooks trends in the provision of undergraduate versus graduate instruction and does not uniformly apply to each of the UW System's institutions.

For example, at UW-Madison, the average amount of undergraduate instruction provided by faculty has steadily declined, with faculty providing only 4.1 hours of direct contact a week to undergraduates in group course sections during the 1991 fall semester. This decrease can be attributed, in part, to a shift toward graduate instruction.

We also found UW-Madison's reliance on teaching assistants to provide instruction has steadily increased, to 46.6 percent of all direct contact with undergraduates enrolled in group course sections in the 1991 fall semester. Teaching assistants provided 70.9 percent of direct contact in group sections in which the most typical student enrolled was a freshman or sophmore.

At the comphrehensive institutions and the Centers, faculty provide the majority of instruction to undergraduates. However, while average faculty group instructional workloads are more than twice those of the doctoral institutions, a decline in the provision of undergraduate group instruction has taken place at all comprehensive institutions but UW-Stevens Point and UW-Stout. In contrast, individuals instruction efforts have increased at most of the comprehensive institutions.

Until the Board of Regents establishes formal standards regarding teaching loads, the question as to whether faculty are teaching enough to fulfill their responsibilities in the area of undergraduate education will remain.

We appreciate the courtesy and cooperation extended to us by University of Wisconsin staff at the system administration and campus levels. The University's response is Appendix IV.
