STATE OF WISCONSIN CLAIMS BOARD

The State Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin on February 9, 1993, upon the following claims:

THE BOARD FINDS:

Claimants request reimbursement of fuel acquisition costs, plus interest, incurred in completing road grading contracts for the Department of Transportation in 1990. As a result of the Iraqi invasion of Kuwait in August, 1990, claimants experienced substantial increases on the price of gasoline and diesel fuel purchased in Wisconsin. Claimants allege the Department of Transportation agreed to apply fuel adjustments to grading contracts in the event of major market fluctuations. The Department of Transportation rejected all fuel adjustment claims in 1991, because the fuel adjustment provision was not included in the contracts with claimants. The Claims Board does not recommend payment of interest on the amounts claimed.

The Board recommends:

- 1. Payment of \$150,236.43 to Hoffman Construction Company for fuel acquisition costs incurred in completing road grading contracts for the Department of Transportation in 1990. The Board further recommends, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Transportation appropriations ss. 20.395(3)(cq), Stats., (\$24,856.81); 20.395(3)(cz), Stats., (\$176.08); 20.395(3)(cx), Stats., (\$31,683.54); and 20.395(3)(br), Stats., (\$93,520.00).
- 2.Payment of \$38,092.69 to James Peterson Sons, Inc., for fuel acquisition costs incurred in completing road grading contracts for the Department of

Transportation in 1990. The Board further recommends, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Transportation appropriations ss. 20.395(2)(fx), Stats., (\$1,001.92); 20.395(2)(fv), Stats., (\$309.84); 20.395(3)(br), Stats., (\$29,718.34); 20.395(3)(bx), Stats., (\$2,511.30); 20.395(3)(cq), Stats., (\$3,894.84); and 20.395(3)(cx), Stats., (\$656.45).

- 3. Payment of \$50,314.03 to Kaiser Construction, Inc., for fuel acquisition costs incurred in completing road grading contracts for the Department of Transportation in 1990. The Board further recommends, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Transportation appropriations ss. 20.395(3)(bx), Stats., (\$38,429.86); and 20.395(3)(bv), Stats., (\$11,884.17)
- 4. Payment of \$61,895.21 to Mashuda Contractors, Inc., for fuel acquisition costs incurred in completing road grading contracts for the Department of Transportation in 1990. The Board further recommends, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Transportation appropriation s. 20.395(3)(br), Stats.
- 5. Payment of \$4,510.96 to Pagel Construction, Inc., for fuel acquisition costs incurred in completing road grading contracts for the Department of Transportation in 1990. The Board further recommends, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Transportation appropriations. 20.395(3)(cx), Stats., (\$3,445.47); 20.395(3)(cv), Stats., (\$458.46); and 20.395(3)(cq), Stats., (\$607.03).

To the Honorable the Legislature:

Pursuant to the requirements in Wis. Statutes 16.339(4) you will find enclosed a report to the legislature describing the use of Transitional Housing funds awarded under Wis. Statutes 16.339. The report should evaluate the effectiveness of the transitional housing

program and include a recommendation on the continuation of funding to the program.

In addition to the Transitional Housing program we have also included reporting on the use of funds for the Transitional Housing Operating Match Grant under Wis. Statute 16.354, the State Shelter Subsidy Grant under S 16.352 and the HUD Emergency Shelter Grant and HUD Permanent Housing for Handicapped Homeless under S 16.35. Although a report to the Legislature is not required for these programs, we felt it was important for the members of the legislature to see how all facets of the homeless programs administered by the Division of Housing work together to provide effective coordination of both state and federal funds.

In the Transitional Housing program, quarterly reports are required from all grantees. Three quarterly reports have been received from the two agencies in Milwaukee that received funds in June 1992, and one quarterly report has been received from the agencies funded in February 1993. These initial reports have indicated that agencies are achieving the goal of assisting individuals and families in establishing more independent lives.

For FY 92 and FY 93, Transitional Housing funds were used to fund those programs which would provide support and case management services to individuals and families who had successfully completed a transitional housing program. The Transitional Housing funds which will be available for FY 1994 and 1995 may be used to expand the capacity of current providers as well as to encourage the development of additional transitional housing programs in areas of the state which are currently underserved.

To the Honorable the Legislature:

In accordance with s. 619.15(2), Wis. Stats., I am pleased to submit to you the Eleventh Annual Report of the Wisconsin Health Insurance Risk Sharing Plan (HIRSP). The plan was established in 1981 and now offers insurance to 12,707 Wisconsin residents.

The major issue on the 1992 HIRSP agenda was cost containment. The Wisconsin Legislature, the HIRSP Board of Governors, and the Wisconsin Office of the Commissioner of Insurance (OCI) took several steps to control future HIRSP costs.

The Wisconsin Legislature mandated in s. 619.15 (e), Wis. Stat., that HIRSP reduce reimbursement for all health services rendered to HIRSP enrollees by 10%.

The HIRSP Cost Containment Committee was established to study alternative cost containment strategies for the plan.

OCI began to collect comprehensive claims data on HIRSP enrollees with the intention to monitor and anticipate trends in HIRSP claims behavior. For 1992, the data show:

The largest number (114) of 1992 HIRSP inpatient claims involve treatment for diagnostic related group (DRG) 430 - psychoses.

On average, HIRSP enrollees in their mid to late 20s incur the most expensive HIRSP claims. The average claim for people age 25 - 29 is \$3,601 compared to \$3,255 for the entire HIRSP population. HIRSP paid the largest amount of benefits, however, to enrollees between 60 and 64--\$12,561,918.

The most expensive HIRSP claim was for DRG 29 - trauma with stupor or coma (age between 1 hour and 17 years). HIRSP paid \$216,357 for this claim.

In other business, HIRSP has continued to grow in terms of premium collected, assessment collected, claims paid, and health policy issues addressed.

In 1992, HIRSP collected \$22,028,012 in premium from its enrollees. Of the 12,707 HIRSP participants, 29% qualified for the premium subsidy program.

In 1992, Wisconsin health insurance writers paid \$16.5 million in HIRSP assessments.

In 1992, HIRSP paid \$32,259,193 in claims. The plan paid \$15,336,690 in inpatient claims--a 4% increase from 1991.

To assess whether or not HIRSP benefits are comparable to those offered in standard plans in the private market, the Board of Governors has established a committee to examine the types of transplant procedures currently covered and not covered by private plans.

It is hoped that the administrative decision to contract with Blue Cross & Blue Shield United of Wisconsin for HIRSP underwriting and claims processing will improve the plan's operations in the future. Any observed savings in HIRSP's administrative costs would certainly prove beneficial to both HIRSP enrollees and the state of Wisconsin.

The data show that HIRSP continues to be a valuable resource for a large number of Wisconsin citizens.
