To the Honorable the Legislature:

1993 Wisconsin Act 27, created s. 46.277(5m) of the statutes which required the Department of Health and Social Services to submit an annual report on its federal Medicaid Home and Community-Based Services waiver, the Community Integration Program II (CIP II). The attached report covers calendar year 1992 for the CIP II and COP-W (Community Options Program Waiver).

These waivers are designed to relocate or divert elderly and physically disabled persons from nursing homes and finance their care with Medicaid. The level of Medicaid waiver funding must be no greater than the Medicaid cost for nursing home care. The annual report examines both cost and quality of care in the waiver programs.

To the Honorable the Legislature:

We have completed a review of selected management issues within the Department of Public Instruction, as requested by the Joint Legislative Audit Committee. Our review focused on the Department's staffing, distribution of funds under Chapter 2 of the federal Elementary and Secondary Education Act, and procurement procedures.

While the number of authorized full-time equivalent positions within the Department has declined from fiscal year (FY) 1982-83 through FY 1992-93, department decisions have also affected staffing levels. In order to meet required expenditure reductions, the Department has chosen to hold permanent positions vacant, with 41.1 authorized positions held vacant as of December 1992. Additionally, the Department has increased its expenditures for limited-term employes and its employment of supervisory staff. These practices raise questions as to whether staff resources are efficiently used.

The Department's administration of the State's block grant under Chapter 2 appears to comply with federal requirements. However, concerns can be raised about the Department's use of the 20 percent it retains for statewide purposes. We question the increased use of funds for indirect costs and recommend changes in the process through which special projects are selected to receive a portion of the funding.

While the Department appears to be in compliance with state procurement policies, changes may be needed in two areas: the process through which it renews solesource contracts, and the use of intergovernmental transfers and grants for the purchase of materials and services.

Finally, the Department may benefit from a review of its policies and practices in three other areas: 1) the reimbursement of non-state employe expenses, 2) the number of advisory committees it supports, and 3) its publication of materials for resale.

We appreciate the courtesy and cooperation of the staff of the Department of Public Instruction. The Department's response is Appendix III.
