EXECUTIVE ORDER #222

Relating to a Special Session of the Legislature

I, TOMMY G. THOMPSON, Governor of the State of Wisconsin, pursuant of Article IV, section 11 and Article V, section 4 of the Constitution of Wisconsin, do amend Executive Order 220 and 221, and additionally require the consideration of the following legislative business:

To consider a nomination for appointment by the Governor to the Board of Regents requiring confirmation by the Senate.
