On behalf of the Wisconsin Acid Deposition Research Council and pursuant the 1985 Wisconsin Act 296, I am pleased to submit our 1994 Biennial Report, A Status Report of Acid Rain Research in Wisconsin.

The report speaks directly to the State's accomplishments in acid rain research over the last two years and our expectations for the future. The report also demonstrates that Wisconsin continues to lead the nation in both acid deposition policy and research commitments.

During the remaining two years of the Council, the major emphasis will be to assess the effectiveness of sulfur dioxide reductions and to address any remaining related research issues and concerns. The Council is also exploring the option of using its structure as a model for addressing other issues such as renewable energy and climate change. In any event, long term monitoring of acid deposition will be required to fully evaluate the impacts on the environment and on the overall quality of life of Wisconsin's citizens.

We thank you for your support in our efforts. We are available to further discuss this report and its implications at your convenience.

To the Honorable the Legislature:

We have completed an evaluation of the Wisconsin School for the Deaf and the Wisconsin School for the Visually Handicapped, as requested by 1993 Wisconsin Act 16. In addition to providing a residential education program to visually or hearing impaired students, the two schools also operate summer programs and provide outreach services for such persons.

A significant trend affecting both schools has been declining enrollments; one-third fewer students are enrolled in the current school year than were enrolled 20 years ago. Currently, 173, or 9.7 percent of hearing impaired students statewide are enrolled in the School for the Deaf; 80, or 8 percent of the visually impaired

students are enrolled in the School for the Visually Handicapped.

In reviewing the schools' staffing levels and facilities usage, we found that little has been done to make operational adjustments in response to declining enrollments. For example, staffing levels continue to be determined without guidelines, and space is underutilized. Given that it is unlikely enrollments will return to previous levels, both schools need to modify their current staffing and facilities management practices to reflect current demands.

Additionally, because more hearing and visually impaired students are being educated by local school districts, it may be appropriate for the state schools to provide additional support to efforts to educate these students. Both schools could, for example, place a greater emphasis on their summer school and outreach services programs.

We appreciate the courtesy and cooperation extended to us by staff and officials of the Department of Public Instruction, the School for the Deaf, and the School for the Visually Handicapped. The Department's response is the appendix.

1993 Wisconsin Act 16 required DOT and the new Railroad Commissioner to conduct a study to identify statutes relating to transportation regulation, particularly those previously administered by the Office of the Commissioner of Transportation. The Act requires the agencies to identify statutes that are obsolete, antiquated, preempted by federal law and to

determine whether references to "farm crossing" in the statutes should be replaced with "private crossing," and to report to the Governor and the Legislature by July 1, 1994.

Initial study by the agencies indicates a substantial number of statutory provisions, primarily in Chapters 191, 192 and 195, that fall within the mandate of Wisconsin Act 16. Due to the large number of statutory provisions under consideration and the varying and complex issues to be considered, the agencies submit this letter and the enclosed document as an initial update to the Governor and Legislature.

DOT and the Office of the Commissioner of Railroads plan to continue to meet to pursue final recommendations on the issues generated by a review of this magnitude, and we will be submitting a final report to you and the Legislature before the 1995 legislative session commences.

Pursuant to Section 234.93(4)(b), I am providing a statement of the amounts deducted to pay outstanding claims and to fund guarantees under each of the programs guaranteed by funds from the Wisconsin Development Reserve Fund (the "Fund") along with an explanation as to how each amount was determined.

The Wisconsin Housing and Economic Development Authority (the "Authority") administers the Fund in accordance with Wisconsin Statute s. 234.93. The Authority is currently authorized to issue guarantees not to exceed \$64,087,000 for eleven initiatives.

Staff has performed the calculation for the balance transfer according to s. 234.93(4)(a). It is estimated that on June 30, 1994 all outstanding claims will have been paid and outstanding guarantees will total \$43,142,825. The Fund balance will total approximately \$15,500,429.

As a result of the calculation, there will be no transfer of funds on June 30, 1994 to the general fund.

Attached is a fifteen year projection of the activity of the state programs within the Fund along with the assumptions used to prepare the projections. The relatively low interest rates which have been available have not had a positive impact on the earnings of the Fund. Staff has been working diligently to improve the longevity of the Fund by investing in higher yielding investments, charging fees, and only approving tourism subsidies where a significant need for the subsidy is demonstrated.

It should be noted that fiscal year 2000 is the last year that guarantee activity as compared to the Fund balance would be in compliance with the 4:1 leverage ratio implemented by the Authority. We believe this is a situation to be closely monitored. Due to our limited experience in issuing guarantees, we believe the 4:1 ratio is prudent. We recognize that it might be appropriate to modify this ratio as we gain additional experience in administering these funds. The other alternatives include limiting guarantees issued and increasing the Fund balance.

This is the annual report on Badger State Industries (BSI) for the fiscal year ending on June 30, 1993, as required by Wisconsin Stats. s. 303.018. This report includes the cash balance of each industry, the amounts expended by state agencies for wood furniture and printing and the portion of those amounts provided by BSI, a projection of the year end cash balance and, if negative, whether it will be offset by assets.

The cash deficit has increased by \$517,394.65 from \$-3,570,064.38 to \$-4,087,459.03 in fiscal year 1993. The increase in the deficit is the result of producing and shipping several large orders for which payment will be made in the next fiscal year. Total assets of plant, equipment and inventories of \$5,242,091 exceed the cash deficit by \$1,154,631.97.

See Appendix A for a summary of the cash balance for each industry and the overall financial condition of BSI.

The net income on the accrual accounting basis was \$554,887 for the fiscal year ending June 30, 1993.

State agencies spent \$1,235,823 on wood furniture in FY 93. Of that amount, \$862,161 or seventy percent was purchased from BSI. During the same period, state agencies purchased \$35,495,965 in printing from all sources. Of that amount, \$1,051,826 or three percent was purchased from BSI. State printing bulletins now require

that all forms for which BSI has negotiated a contract be purchased from BSI. Appendix B provides comparisons with FY 92.

Attached is the third quarter report on Badger State Industries for the fiscal year ending June 30, 1994, as required by Section 303.019 of the Wisconsin Statutes. This report includes the year-to-date cash balance of each industry.

The March 31, 1994, cash balance of each industry is detailed in Appendix A. On that date the total cash deficit was \$3,590,703.40. On a cash basis, Badger State Industries had a cash surplus of just under \$500,000 through the third quarter ending 3/31/94. This is a significant change form the \$500,000 deficit as of 12/31/93. Several large systems furniture orders totalling \$600,000 invoiced in December received payment in the third quarter of this fiscal year as well as a concerted effort to reduce accounts receivables resulted in this change. Badger State Industries has adequate fixed assets, inventories and receivables to cover the overdraft.

The projected profit on the accrual basis is \$133,000 for the fiscal year ending June 30, 1994. The projected statement is on the accrual basis and was prepared based on the best fiscal data available through March 31, 1994. The projection is based on the budget as of 3/31/94. Additional spending authority to increase sales was requested and approved in the Budget Adjustment Bill and a 16.515 request in April of 1994. The increased expenditure authority is not reflected in the projections contained in this document.
