We have completed an audit of the State's risk administered management pprogram,

Department of Administration to reduce the costs and risks of losses from injuries to state employes, damage to state property, and liability claims made by those who believe they have been injured in the course of government operations. Most losses are self-insured by the State.

Workers' compensation losses are the most costly; annual claims payments have increased 148 percent, from \$4.8 million in fiscal year (FY) 1984-85 to \$11.9 million in FY 1993-94. the Department has taken several steps in recent years to improve its claims management and loss control activities. A leveling of claims payments during FY 1993-94 suggests that these efforts may help control costs. We recommend other management improvements and steps to control costs, including the coordination of a formal statewide program that promotes quick return to work by injured employes.

Property and liability claims payments also have increased in recent years, from \$4.9 million in FY 1984-85 to \$9.2 million in FY 1993-94. Further, payments for environmental cleanup present a new challenge to limit current and future costs for sites, such as leaking underground storage tanks, landfills, and other hazardous waste sites, that have caused soil or groudwater contamination. The Department estimates the cleanup costs for known sites, which will be paid by the risk management program and individual state agencies, may exceed \$18 million.

The Legislature may want to consider steps to limit the benefits currently available under the hazardous duty injury pay program, which is an alternative to workers' compenstation for certain individuals, including conservation wardens, members of the State Patrol, and patient-care workers in the State's institutions. As a result of rulings that deemed the pay nontaxable, injured employes under this program receive significantly more pay than they received while working.
