To the Honorable the Legislature:

Pursuant to action taken by the University of Wisconsin System Board of Regents during its regular meeting on November 11, 1994, I am transmitting the Report on Solid Waste Experiment Centers, required under s. 36.25(3m)(e) of the Wisconsin Statutes.

1989 Wisconsin Act 31 created section 36.25(3m)(b) of the statutes which provides that:

"The board may establish one or more solid waste experiment centers for the purpose of developing, demonstrating, promoting and assessing the costs and environmental effects of alternative to solid waste disposal. The board shall determine the location of the solid waste experiment centers. In making the determination, the board shall consider the solid waste disposal needs of the various regions of the state. The board may establish, through cooperative agreements, solid waste experiment centers at existing publicly owned or privately owned storage, treatment or disposal facilities."

Section 36.25(3m)(e) provides that:

"Annually, the board shall submit a report to the chief clerk of each house of the legislature for distribution the appropriate standing committees under s. 13.172(3) on all activities undertaken under this subsection."/XI

This is the fifth annual report submitted to meet the statutory requirements. The College of Natural Resources at UW-Stevens Point was designated as a Solid Waste Experiment Center in June 1990, and the Water Research and Education Center, UW-Madison College of Engineering was designated a Center in February 1994. Beginning in fiscal year 1990-91, the recycling law (1989) Wisconsin Act 335) provided additional research funding and directed the Board of Regents to appoint a Solid Waste Research Council to advise the System concerning the awarding of funds for research projects under 36.25(3m)(c). In response to the requests for proposals issued to disburse 1994-95 funding, the 11-member Council received 19 research proposals from eight UW System campuses. The Council reviewed the proposals and two experts on the specific subjects were sought for each proposal. I granted approval to fund 11 projects recommended by the Council totaling \$299,905. These projects are summarized in the report.

State of Wisconsin Legislative Audit Bureau

To the Honorable the Legislature:

We have completed an evaluation of the Office of the State Public Defender, as requested by the Joint Legislative Audit Committee. The Office provides constitutionally required legal representation to indigent persons who have been charged with crimes for which the potential sentence could include incarceration, as well as representation in other cases specified by statute.

The Office's budget has grown \$25.6 million, or 75.7 percent, between fiscal year (FY) 1989–90 and FY 1993–94. This growth was caused by several factors: caseload increases, 34 percent; compensation increases for state staff and the private bar, 33.2 percent; staff workload decreases, 17.2 percent; private bar cost increases other than compensation, 8.6 percent; and administrative and other costs, 7 percent.

The primary factors affecting the Office's budget are determined by external forces, such as increases in caseload and statewide salary negotiations. Nevertheless, several other factors that affect costs, such as efficiency and effective administration, can be influenced by management. We include recommendations for the Office to begin verifying indigence claims, instead of following the current practice of accepting clients' unsupported statements, and to begin collection efforts against clients whose financial situation improves. We also include recommendations for the Office to improve its monitoring of private attorneys, including reviewing for potential billing fraud, as well as reviewing the quality and efficiency of representation. In addition, we include a recommendation for the Office to fully implement a 1983 statutory directive to establish a case management system.

A number of staff in the Office raised concerns about the Office's personnel practices. Because these were outside the scope of our audit, we did not investigate these concerns but have forwarded them to the State Public Defender in a separate management letter.

We appreciate the courtesy and cooperation extended to us by staff in the Office of the State Public Defender. The Office's response to the audit is the appendix.
