To the Honorable the Legislature:

As required by s. 13.94, Wis. Stats., we have completed a financial audit of the Patients Compensation Fund, which provides medical malpractice insurance coverage in excess of statutory minimums to Wisconsin's health care providers. The Fund is governed by a Board and administered by the Office of the Commissioner of Insurance. We are able to provide an unqualified auditor's report on the Fund's financial statements for the fiscal years ending June 30, 1994 and 1993.

A continuing concern facing the Fund is an accounting deficit, which was \$67.9 million as of June 30, 1994. The Fund's financial position has improved in recent years and does not pose an immediate concern. However, if cash flow problems develop in the long term, they will be more difficult to address than if steps are taken now to develop a strategy to further reduce the deficit.

In response to these financial concerns, the Board established a special committee to evaluate options for addressing the deficit. Three of the four options the committee recommended to the Board require legislative changes, including establishing a limit on non-economic damages, setting a statutory minimum level to the fee assessed health care providers, and allowing the fund to pay future medical expenses out on an as-incurred basis rather than as a lump-sum payment.

Another continuing concern is a potential conflict of interest that exists when the claims contractor purchases claim settlement annuities through its internal brokerage department. We do not believe the Board's plans to more closely monitor annuity purchases will eliminate the potential for the claims contractor to act in its own, rather than the Fund's, best interest, and we again recommend that the claims contractor and its affiliates be prohibited from benefiting on annuity purchases for the Fund.

We appreciate the courtesy and cooperation extended to us by the staff of the Office of the Commissioner of

Insurance and the contracts who help administer the Patients Compensation Fund program. The response from the Commissioner of Insurance is the appendix.
