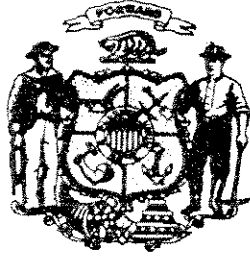

On August 24, 1993, an addendum to the interstate educational agreement between Blackhawk Technical College and Rock Valley College in Rockford, Illinois was submitted by the State Board of Vocational, Technical and Adult Education (VTAE) for approval by the Joint Committee on Finance. We have attached a copy of the addendum, as well as a memorandum from the Legislative Fiscal Bureau describing the proposed changes to the agreement and the Committee's function in regard to the approval of such agreements.

The addendum changes the titles of eight courses offered at Blackhawk and deletes one course which is no longer offered at Rock Valley. These modifications are technical in nature and have no effect on the basic terms of the agreement. 



On August 24, 1993, the State Board of Vocational, Technical and Adult Education (VTAE) submitted to the Joint Committee on Finance, an addendum to the interstate educational agreement between Blackhawk Technical College and Rock Valley College in Rockford, Illinois. I am providing information relating to this reciprocity agreement and the approval of changes to such agreements by the Joint Committee on Finance.

The addendum, a copy of which is attached, was approved by the governing boards of Blackhawk Technical College and Rock Valley College in July, 1993. The addendum changes the titles of eight courses offered at Blackhawk and deletes one course which is no longer offered at Rock Valley. The reciprocity agreement was last modified in 1991 when the elimination of Wisconsin interdistrict tuition necessitated changes in the tuition rates charged at the institutions. The Committee approved the changes in tuition rates at its s. 13.10 meeting in October, 1991.

Section 39.42 of the statutes allows the governing boards of any publicly supported, postsecondary institution, with the approval of the Higher Educational Aids Board (HEAB) and the Joint Committee on Finance, to enter into reciprocity agreements with appropriate state educational institutions in other states. The VTAE system currently has agreements with institutions in three states: Minnesota, Michigan and Illinois. These agreements are intended to provide students the opportunity to attend institutions which are more conveniently located or which offer programs not available in the students' states of residency. Under the current VTAE reciprocity agreements with Illinois (which include the agreement between Blackhawk and Rock Valley), participating students from both states are charged Wisconsin resident tuition. In 1992-93, Blackhawk sent 14 students to Rock Valley while 47 students from the Rockford area attended Blackhawk.

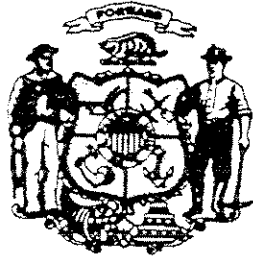
