Receipts

Request

The University of Wisconsin System requests approval of \$2,000,000 additional expenditure authority in s. 20.285 (1)(iz), General Operations Receipts.

Background

The UW General Operations Receipts appropriation incorporates income from numerous "mission-related" activities, including sale of instructional materials, copy center operations, conferences, camps and workshops. ["Student-related" operations are generally included in the Auxiliaries appropriation.] Revenues are expended for costs related to the activities.

The request for additional spending authority reflects increased activity at several UW institutions for conferences, workshops and educational camps. Items included in the request are: 1) \$1.5 million for UW-Madison workshops and outreach programs in the Schools of Business, Education and Engineering and the College of Agricultural and Life Sciences, and 2) \$500,000 for the UW-River Falls Kansas City pro football training camp and other programs at Whitewater, Eau Claire and Stout. These self-supporting programs cover topics such as athletics, music, computers, languages, etc. Students pay a special fee which may include on-site housing and food service. The UW hires faculty or ad hoc staff to teach the workshops.

<u>Analysis</u>

The appropriation had an unencumbered cash balance of \$1,445,000 at the close of FY93 and collections of \$14.2 million through 4/94 with UW-projected final FY94 collections of \$18,344,000.

The current allotted spending authority is \$16,385,300 and expenditures through 5/23/94 were \$13,116,900. The most recent UW year-end expenditures projection of \$18,195,000 exceeds the allotted amount by \$1,809,700. While the UW projection is acceptable, it is also possible that financial conditions could change by fiscal year end, eliminating the need for part or all of the additional expenditure authority. To prepare for such an event, it may be prudent to hold the additional authority in unallotted reserve,

pending receipt of demonstrated actual need from the UW.

Projected revenues appear almost equal to the requested spending authority. The UW case for additional spending authority and the expenditure items comprising the request appear reasonable and appropriate, with the precaution mentioned above.

Although not specified in the written request, it is the UW's intent that all additional spending authority be granted on an ongoing basis. This is reasonable and consistent with past experience. The use of prior year cash reserves mentioned in the UW request appears to be no longer necessary and has been deleted from the request.

Recommendation

Approve \$1,809,700 ongoing expenditure authority, to be held in unallotted reserve for FY94 pending documentation of actual need by the UW.

The University of Wisconsin System requests increased expenditure authority of \$2,000,000 for the appropriation under s.20.285(1)(iz). Expenditures in this appropriation are related to Other Operating Receipts of the University and accounted for under our Fund 136.

The current allotment for this appropriation is \$16.4 million; it is now projected that current year revenues and expenditures will exceed \$18 million. A new spending level of \$18.4 million will allow the University to meet the increased demands for its programs. In addition to current year excess revenues of \$1.6 million, UW campuses have identified uses for approximately \$.4 million of cash reserves generated from prior years operations.

All University of Wisconsin campuses have participated in a mid-year revenue and expenditure analysis, and budget authority has been reallocated internally as much as possible. However, the success and expansion of various existing programs have caused the increase in revenues, and thereby an equivalent increase in spending to support those programs.

At UW-Madison, workshops and outreach programs in the Schools of Business, Education and Engineering and the College of Agricultural and Life Sciences have experienced unexpected demands of approximately \$1.5 million. In order to accommodate the needs of the participants (lodging, food, course materials and instruction costs), increased commitments to vendors have occurred. The satisfaction of these commitments will place excessive demands on the University's overall spending authority for 1993-94.

UW-River Falls is projecting additional revenues in excess of \$.5 million for their Kansas City pro football training camp, the Soviet Tour and the China Tour. UW-Whitewater has reported a major increase in participation in conferences and summer camps, as have UW-Eau Claire and UW-Stout in their Jazz Festival, Client Services Institute's teleconferences and English Language Institute's Japanese Program.

Internal reallocations of budget authority can accommodate only a portion of these situations. These programs are primarily continuing in nature, and the success of each is dependant on the ability to respond promptly to market demands. Increased demand generates greater revenues, but requires increased levels of spending for personal services, supplies and expenses and capital investment.

The increased spending authority is needed as follows:
