



**ASSEMBLY AMENDMENT 35,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO 1995 ASSEMBLY BILL 150**

June 21, 1995 – Offered by Representatives NOTESTEIN, BOCK, KRUG, LA FAVE, RILEY, GROBSCHMIDT, KRUSICK, WASSERMAN, CULLEN, MORRIS-TATUM and CARPENTER.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 291, line 4: after that line insert:

3 “(i) Other employes PR A 148,400 153,600”.

4 **2.** Page 463, line 24: after that line insert:

5 “SECTION 1035t. 20.475 (1) (i) of the statutes is created to read:

6 20.475 (1) (i) *Other employes*. The amounts in the schedule to reimburse the  
7 county for the costs of clerks necessary for the prosecution of violent crime cases  
8 under s. 978.13 (1) (c) and clerks providing clerical services under s. 978.13 (1) (b) to  
9 prosecutors handling cases involving felony violations under ch. 161. Five percent  
10 of the moneys received under s. 814.635 shall be credited to this appropriation  
11 account.”.

12 **3.** Page 2193, line 8: delete “\$5” and substitute “\$5.30”.

13 **4.** Page 2248, line 9: delete lines 9 to 20 and substitute:

14 “SECTION 7293g. 978.13 (1) (b) of the statutes is amended to read:

1           978.13 (1) (b) In counties having a population of 500,000 or more, the salary  
2 and fringe benefit costs of 2 clerk positions providing clerical services to the  
3 prosecutors in the district attorney's office handling cases involving felony violations  
4 under ch. 161. The state treasurer shall pay the amount authorized under this  
5 paragraph to the county treasurer pursuant to a voucher submitted by the district  
6 attorney to the department of administration from the appropriation under s. 20.475  
7 (1) ~~(h)~~ (i). The amount paid under this paragraph may not exceed \$61,100 \$65,800  
8 in the ~~1993-94~~ 1995-96 fiscal year and ~~\$63,600~~ \$68,100 in the ~~1994-95~~ 1996-97  
9 fiscal year.

10           **SECTION 7293h.** 978.13 (1) (b) of the statutes, as affected by 1995 Wisconsin Act  
11 .... (this act), is amended to read:

12           978.13 (1) (b) In counties having a population of 500,000 or more, the salary  
13 and fringe benefit costs of 2 clerk positions providing clerical services to the  
14 prosecutors in the district attorney's office handling cases involving felony violations  
15 under ch. 161. The ~~state treasurer~~ secretary of administration shall pay the amount  
16 authorized under this paragraph to the county treasurer pursuant to a voucher  
17 submitted by the district attorney to the department of administration from the  
18 appropriation under s. 20.475 (1) (i). The amount paid under this paragraph may not  
19 exceed \$65,800 in the 1995-96 fiscal year and \$68,100 in the 1996-97 fiscal year.

20           **SECTION 7293i.** 978.13 (1) (c) of the statutes is amended to read:

21           978.13 (1) (c) In counties having a population of 500,000 or more, the salary and  
22 fringe benefit costs of clerk positions in the district attorney's office necessary for the  
23 prosecution of violent crime cases primarily involving felony violations under s.  
24 939.63, if a felony is committed while armed, and under ss. 940.01 to 940.03, 940.05,  
25 940.06, 940.225, 943.23 (1g), (1m) and (1r) and 943.32 (2). The state treasurer shall

1 pay the amount authorized under this paragraph to the county treasurer pursuant  
2 to a voucher submitted by the district attorney to the secretary of administration  
3 from the appropriation under s. 20.475 (1) ~~(e)~~ (i). The amount paid under this  
4 paragraph may not exceed ~~\$76,800~~ \$82,600 in the ~~1993-94~~ 1995-96 fiscal year and  
5 ~~\$79,800~~ \$85,500 in the ~~1994-95~~ 1996-97 fiscal year.

6 **SECTION 7293j.** 978.13 (1) (c) of the statutes, as affected by 1995 Wisconsin Act  
7 .... (this act), is amended to read:

8 978.13 (1) (c) In counties having a population of 500,000 or more, the salary and  
9 fringe benefit costs of clerk positions in the district attorney's office necessary for the  
10 prosecution of violent crime cases primarily involving felony violations under s.  
11 939.63, if a felony is committed while armed, and under ss. 940.01 to 940.03, 940.05,  
12 940.06, 940.225, 943.23 (1g), (1m) and (1r) and 943.32 (2). The ~~state treasurer~~  
13 secretary of administration shall pay the amount authorized under this paragraph  
14 to the county treasurer pursuant to a voucher submitted by the district attorney to  
15 the secretary of administration from the appropriation under s. 20.475 (1) (i). The  
16 amount paid under this paragraph may not exceed \$82,600 in the 1995-96 fiscal year  
17 and \$85,500 in the 1996-97 fiscal year.”.

18 **5.** [Page 2485, line 1](#): delete “and 978.12 (5) (c) 1.” and substitute “, 978.12 (5)  
19 (c) 1. and 978.13 (1) (b) (by SECTION 7293h) and (c) (by SECTION 7293j)”.
