**REFERRAL OF AGENCY REPORTS**

To the Honorable, the Legislature:

The 1995 Wisconsin Act 27 requires the Department of Health and Social Services to develop a policy to address the use of scheduled and unscheduled leave, including sick leave by employees of the juvenile correctional institutions. The division of Youth Services (DYS) has begun discussions with AFSCME Council 24 Wisconsin State Employees Union AFL-CIO and its Appropriate Affiliated Locals to inform them of this statutory requirement.

Before any policy can be implemented, it must follow the procedure outlined in the WSEU union contract. For example, a 30-day advance notice of the written policy must be provided to the local unions and to all current employees.

Because biennial union/management negotiations have precedent, time was not sufficient to complete a new sick leave policy.

As an interim measure, DYS will implement measures to reduce the use of overtime and will continue discussions with the union to implement the directive for the Legislature. Because DYS will be transferring to the Department of Corrections (DOC) July, 1996, DYS must seek input from DOC and local unions prior to implementation of any changes in sick leave policy.

The attached report outlines the background of the issues, current steps being taken to control overtime, and the implementation process DYS will be following.

1983 Wisconsin Act 27 created s. 46.277 (5m) of the statutes, which requires the Department of Health and Social Services to submit an annual report on its federal Medicaid Home and Community-Based Services waiver, the Community Integration Program II (CIP II). The attached report covers calendar year 1994 for the CIP II and COP-Waiver (Community Options Program Waiver).

These waivers are designed to relocate or divert elderly and physically disabled persons from nursing homes and finance their care with Medicaid. The level of Medicaid waiver funding must be no greater on average than the Medicaid cost for nursing home care. The annual report examines both cost and quality of care in the waiver programs and compares average costs in the waiver program to average nursing home costs.

A second report detailing other public costs incurred by community-based and institutional recipients of Medicaid long-term care services is prepared in conjunction with the annual waiver report. This detail report of public costs has been provided to the Legislative Fiscal Bureau and additional copies are available upon request.

The Recycling Market Development Board submits this strategic plan to the Wisconsin Legislature in fulfillment of ss.159.41 of the Wisconsin Statutes. This plan is delivered to the Chief Clerk in each House of the Legislature per the requirements in ss. [13.172\(3\)](#), Wisconsin Statutes.

Landfill and incineration bans on certain recoverable items in the municipal solid waste stream were enacted by [1989 Wisconsin Act 335](#), also known as the "recycling law". [1993 Wisconsin Act 75](#) created the Recycling Market Development Board (RMDB) to coordinate market development activities for these recovered materials. The legislated purpose of the RMDB is to promote the development of sustainable, high-value markets for recovered materials on behalf of, and in cooperation with waste generators, and to promote the orderly and efficient marketing of these materials.

The 1995-97 Biennial Budget directed the RMDB to prepare a strategic plan to "guide the development and implementation of the board's activities" (ss.159.41 Wisconsin Statutes). The Board has fulfilled the statutory requirement in preparing its strategic plan. This plan sets forth measurable goals, a priority list of materials for funding, project funding criteria, as well as action plans for the high ranking materials on the priority list. Additionally, the plan denotes the relationships between the RMDB, business, industry, and government.

The planning process was very thorough. Over one hundred representatives from recycling businesses, the recycling industry, and state and local government all participated in the strategic planning process, offering information through interviews, feedback sessions, and public comment. Market and material studies were also conducted to obtain the most reliable data available.

The Recycling Market Development Board respectfully submits its strategic plan for dispersal to the appropriate standing committees of the Wisconsin Senate.
