



## 1995 SENATE BILL 428

November 16, 1995 - Introduced by Senators SCHULTZ and RISSER, cosponsored by Representatives FREESE and MUSSER. Referred to Joint survey committee on Retirement Systems.

1     **AN ACT to amend** 40.02 (48) (am) and 40.02 (48) (c); and **to create** 40.02 (17) (m)  
2             and 40.65 (4v) of the statutes; **relating to:** classifying state probation and  
3             parole officers, county jailers, and security officers at Wisconsin national guard  
4             facilities as protective occupation participants for the purposes of the Wisconsin  
5             retirement system.

### *Analysis by the Legislative Reference Bureau*

Under current law, participants under the Wisconsin retirement system (WRS) whose principal duties involve law enforcement or fire suppression or prevention and require frequent exposure to a high degree of danger or peril and a high degree of physical conditioning are classified as protective occupation participants. Current law specifically classifies police officers, fire fighters and various other individuals as protective occupation participants. Under the WRS, the normal retirement age of a protective occupation participant is lower than that of other participants and the percentage multiplier used to calculate retirement annuities is higher for protective occupation participants than for other participants.

This bill specifically classifies state probation and parole officers, county jailers, and security officers at Wisconsin national guard facilities as protective occupation participants for the purposes of the WRS.

This bill will be referred to the joint survey committee on retirement systems for a detailed analysis, which will be printed as an appendix to the bill.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

1           **SECTION 1.** 40.02 (17) (m) of the statutes is created to read:

2           40.02 **(17)** (m) Notwithstanding par. (d), each participant who is a state  
3 probation and parole officer, county jailer, or security officer at a Wisconsin national  
4 guard facility on or after the effective date of this paragraph .... [revisor inserts date],  
5 shall be granted creditable service as a protective occupation participant for all  
6 covered service as a state probation and parole officer, county jailer, or security officer  
7 at a Wisconsin national guard facility that was earned on or after the effective date  
8 of this paragraph .... [revisor inserts date], but may not be granted creditable service  
9 as a protective occupation participant for any covered service as a state probation  
10 and parole officer, county jailer, or security officer at a Wisconsin national guard  
11 facility that was earned before the effective date of this paragraph .... [revisor inserts  
12 date], unless that service was earned while the participant was classified under sub.  
13 (48) (a) and s. 40.06 (1) (d) as a protective occupation participant.

14           **SECTION 2.** 40.02 (48) (am) of the statutes is amended to read:

15           40.02 **(48)** (am) "Protective occupation participant" includes any participant  
16 whose name is certified to the fund as provided in s. 40.06 (1) (d) and (dm) and who  
17 is a conservation warden, conservation patrol boat captain, conservation patrol boat  
18 engineer, conservation pilot, conservation patrol officer, forest fire control assistant,  
19 member of the state patrol, state motor vehicle inspector, police officer, fire fighter,  
20 sheriff, undersheriff, deputy sheriff, state probation and parole officer, county jailer,  
21 security officer at a Wisconsin national guard facility, county traffic police officer,  
22 state forest ranger, fire watcher employed by the Wisconsin veterans home, state  
23 correctional-psychiatric officer, excise tax investigator employed by the department  
24 of revenue, special criminal investigation agent in the department of justice,  
25 assistant or deputy fire marshal, or person employed under s. 61.66 (1).

1           **SECTION 3.** 40.02 (48) (c) of the statutes is amended to read:

2           40.02 (48) (c) In s. 40.65, “protective occupation participant” means a  
3 participating employe who is a police officer, fire fighter, an individual determined  
4 by a participating employer under par. (a) or (bm) to be a protective occupation  
5 participant, county undersheriff, deputy sheriff, state probation and parole officer,  
6 county jailer, security officer at a Wisconsin national guard facility, county traffic  
7 police officer, conservation warden, state forest ranger, field conservation employe  
8 of the department of natural resources who is subject to call for forest fire control or  
9 warden duty, member of the state traffic patrol, state motor vehicle inspector,  
10 university of Wisconsin system full-time police officer, guard or any other employe  
11 whose principal duties are supervision and discipline of inmates at a state penal  
12 institution, excise tax investigator employed by the department of revenue, person  
13 employed under s. 61.66 (1), or special criminal investigation agent employed by the  
14 department of justice.

15           **SECTION 4.** 40.65 (4v) of the statutes is created to read:

16           40.65 (4v) A state probation and parole officer, county jailer, or security officer  
17 at a Wisconsin national guard facility who becomes a protective occupation  
18 participant on or after the effective date of this subsection .... [revisor inserts date],  
19 is not entitled to a duty disability benefit under this section for an injury or disease  
20 occurring before the effective date of this subsection .... [revisor inserts date].

21           **SECTION 5. Effective date.**

22           (1) This act takes effect on the January 1 after publication.
