**SENATE AMENDMENT 1,
TO 1997 ASSEMBLY BILL 601**

May 5, 1998 - Offered by JOINT COMMITTEE ON FINANCE.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 6: delete "appropriations" and substitute "an appropriation".

3 **2.** Page 4, line 6: after "(a)" insert ". If an agreement under s. 48.975 (4) is in
4 effect that provides for a payment of \$0 under s. 48.975 (3) (a), the payment of \$0 shall
5 be considered to be an adoption assistance maintenance payment for purposes of this
6 subdivision".

7 **3.** Page 4, line 12: delete lines 12 to 19.

8 **4.** Page 5, line 1: delete lines 1 and 2.

9 **5.** Page 7, line 4: delete that line and substitute:

10 "SECTION 8m. 48.975 (4) of the statutes is renumbered 48.975 (4) (a) and
11 amended to read:".

12 **6.** Page 7, line 5: delete "PROCEDURE" and substitute "(a)".

1 **7.** Page 11, line 1: delete that line and substitute:

2 “**SECTION 9122. Nonstatutory provisions; health and family services.**”.

3 **8.** Page 12, line 4: delete lines 4 to 19.

4 **9.** Page 13, line 1: delete lines 1 to 16.

5 **10.** Page 14, line 1: delete lines 1 to 5 and substitute “than January 1, 1999.

6 (3m) The authorized FTE positions for the department of health and family
7 services are increased by 0.5 FED positions on July 1, 1998, to be funded from the
8 appropriation under section 20.435 (3) (n) of the statutes, for the purpose of
9 administering the adoption assistance program.”.

10 **11.** Page 14, line 6: delete that line and substitute:

11 “**SECTION 9222. Appropriation changes; health and family services.**”.

12 **12.** Page 14, line 7: delete lines 7 to 14.

13 **13.** Page 15, line 7: delete lines 7 to 18.

14 **14.** Page 16, line 1: delete lines 1 to 8 and substitute:

15 “**SECTION 9228. Appropriation changes; joint committee on finance.**

16 (1m) In the schedule under section 20.005 (3) of the statutes for the
17 appropriation to the joint committee on finance under section 20.865 (4) (a) of the
18 statutes, as affected by the acts of 1997, the dollar amount is decreased by \$54,300
19 for fiscal year 1998–99 to decrease funding for the purpose of administering the
20 adoption assistance program.

21 **SECTION 9322. Initial applicability; health and family services.**”.

22 **15.** Page 17, line 1: delete lines 1 to 8, as affected by assembly amendment 1,
23 and substitute:
