



**ASSEMBLY AMENDMENT 30,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO 1997 ASSEMBLY BILL 768**

May 6, 1998 - Offered by Representatives MEYER and HUBER.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 15, line 3: after "program;" insert "food stamps for qualified aliens;".

3 **2.** Page 43, line 4: after that line insert:

4 **"SECTION 45q.** 20.445 (3) (dz) of the statutes, as affected by 1997 Wisconsin Act  
5 27, section 627, is amended to read:

6 20.445 (3) (dz) (title) *Wisconsin works and other public assistance*  
7 *administration and benefits.* The amounts in the schedule for administration and  
8 benefit payments under Wisconsin works under ss. 49.141 to 49.161, the job  
9 opportunities and basic skills program under s. 49.193, the learnfare program under  
10 s. 49.26, the work experience and job search program under s. 49.36, the food stamp  
11 employment and training program under s. 49.124 (1m) and the parental  
12 responsibility pilot program under s. 49.25; for payment distribution under s. 49.33

1 (8) for county administration of public assistance benefits and medical assistance  
2 eligibility determination and payments to American Indian tribes for administration  
3 of public assistance programs; to provide state aid for county administered public  
4 assistance programs for which reimbursement is provided under s. 49.33 (9); for child  
5 care costs under ss. 49.191 (1) and (2), 49.193 (8) and 49.26 (1) (e); for the new hope  
6 project under s. 49.37; for aid to 18-year-old students under s. 49.20; and for funeral  
7 expenses under s. 49.30. Payments may be made from this appropriation to counties  
8 for fraud investigation and error reduction under s. 49.197 (1m) and (4). Moneys  
9 appropriated under this paragraph may be used to match federal funds received  
10 under par. (md). Notwithstanding ss. 20.001 (3) (a) and 20.002 (1), the department  
11 may transfer funds between fiscal years under this paragraph. All funds allocated  
12 by the department but not encumbered by December 31 of each year lapse to the  
13 general fund on the next January 1 unless transferred to the next calendar year by  
14 the joint committee on finance.”.

15 **3.** Page 133, line 17: after that line insert:

16 **“SECTION 192p.** 49.124 (1) (df) of the statutes is created to read:

17 49.124 (1) (df) “Qualified alien” has the meaning given in 8 USC 1641 (b).

18 **SECTION 192q.** 49.124 (8) of the statutes is created to read:

19 49.124 (8) BENEFITS FOR QUALIFIED ALIENS. Not later than July 1, 1998, the  
20 department shall submit a plan to the secretary of the federal department of  
21 agriculture to provide benefits under this section to a qualified alien who is ineligible  
22 for benefits under this section solely because of the application of 8 USC 1612 or 1613.  
23 If the secretary of the federal department of agriculture approves the plan, the  
24 department shall provide benefits under this section beginning on July 1, 1998, or

1 on the day that the plan is approved, whichever is later, to a qualified alien who is  
2 otherwise eligible for benefits under this section.”.

3 **4.** Page 134, line 25: after that line insert:

4 **“SECTION 193gt.** 49.175 (1) (fs) of the statutes is created to read:

5 49.175 (1) (fs) *Food stamps for legal immigrants.* For food stamp benefits  
6 provided under s. 49.124 (8) to qualified aliens, as defined in 8 USC 1641 (b),  
7 \$4,600,000 in fiscal year 1998–99. Notwithstanding sub. (2), the department may  
8 not use any funds allocated under this paragraph for any other purpose under this  
9 subsection.”.

10 **5.** Page 199, line 24: delete “P.L. 103–66 and” and substitute “P.L. 103–66  
11 and”.

12 **6.** Page 200, line 2: before “and as” insert “and section 970 of P.L. 105–34”.

13 **7.** Page 210, line 21: delete “P.L. 103–66 and” and substitute “P.L. 103–66  
14 and”.

15 **8.** Page 210, line 23: after “1998,” insert “and section 970 of P.L. 105–34”.

16 **9.** Page 211, line 23: delete “P.L. 103–66, and” and substitute “P.L. 103–66,  
17 and”.

18 **10.** Page 211, line 25: after “1998,” insert “and section 970 of P.L. 105–34”.

19 **11.** Page 212, line 24: delete “P.L. 103–66 and” and substitute “P.L. 103–66  
20 and”.

21 **12.** Page 213, line 2: before “and” insert “and section 970 of P.L. 105–34”.

22 **13.** Page 216, line 8: delete “P.L. 103–66 and” and substitute “P.L. 103–66  
23 and”.
