**SENATE AMENDMENT 1,
TO SENATE SUBSTITUTE AMENDMENT 1,
TO 1997 SENATE BILL 345**

February 12, 1998 - Offered by Senator HUELSMAN.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 4, line 23: after "authority" insert ", making an appropriation".

3 **2.** Page 9, line 4: after that line insert:

4 **"SECTION 15g.** 20.433 (1) (c) of the statutes is created to read:

5 20.433 (1) (c) *Child abuse and neglect prevention grants.* A sum sufficient equal
6 to 0.5% of the total amounts appropriated and estimated to be expended from all
7 sources for the department of corrections for each fiscal year as shown in the schedule
8 under s. 20.005 (3), to be used for grants to organizations under s. 48.982 (4), (6) and
9 (7) and for statewide projects under s. 48.982 (5). The child abuse and neglect
10 prevention board may not encumber or expend more than \$1,749,700 from this
11 appropriation between January 1, 1999, and June 30, 1999.

1 **SECTION 15h.** 20.433 (1) (c) of the statutes, as created by 1997 Wisconsin Act
2 (this act), is amended to read:

3 20.433 (1) (c) *Child abuse and neglect prevention grants.* A sum sufficient equal
4 to 0.5% of the total amounts appropriated and estimated to be expended from all
5 sources for the department of corrections for each fiscal year as shown in the schedule
6 under s. 20.005 (3), to be used for grants to organizations under s. 48.982 (4), (6) and
7 (7) and for statewide projects under s. 48.982 (5). ~~The child abuse and neglect
8 prevention board may not encumber or expend more than \$1,749,700 from this
9 appropriation between January 1, 1999, and June 30, 1999.~~

10 **SECTION 15r.** 20.435 (3) (b) of the statutes is created to read:

11 20.435 (3) (b) *Child abuse and neglect prevention grants and projects.* A sum
12 sufficient equal to 0.5% of the total amounts appropriated and estimated to be
13 expended from all sources for the department of corrections for each fiscal year as
14 shown in the schedule under s. 20.005 (3), to be used for grants to programs and
15 statewide projects the primary goal of which is the prevention of child abuse and
16 neglect. The department of health and family services may not encumber or expend
17 more than \$1,749,700 from this appropriation between January 1, 1999, and June
18 30, 1999.

19 **SECTION 15s.** 20.435 (3) (b) of the statutes, as created by 1997 Wisconsin Act
20 (this act), is amended to read:

21 20.435 (3) (b) *Child abuse and neglect prevention grants and projects.* A sum
22 sufficient equal to 0.5% of the total amounts appropriated and estimated to be
23 expended from all sources for the department of corrections for each fiscal year as
24 shown in the schedule under s. 20.005 (3), to be used for grants to programs and
25 statewide projects the primary goal of which is the prevention of child abuse and

1 neglect. ~~The department of health and family services may not encumber or expend~~
2 ~~more than \$1,749,700 from this appropriation between January 1, 1999, and June~~
3 ~~30, 1999.~~”.

4 **3.** Page 11, line 18: delete lines 18 to 22 and substitute:

5 “46.03 (7) (f) In consultation with the child abuse and neglect prevention board,
6 develop a plan for the expenditure of funds from the appropriation account under s.
7 20.435 (3) (b). The plan shall ensure that funds from the appropriation account
8 under s. 20.435 (3) (b) are not used to supplant any other funding the department
9 provides for the prevention of child abuse and neglect. Beginning in 1999, by June
10 30 of each year the department shall submit a copy of the plan for the next fiscal year
11 to the chief clerk of each house of the legislature, for distribution to the appropriate
12 standing committees under s. 13.172 (3).”.

13 **4.** Page 13, line 3: after that line insert:

14 “**SECTION 32e.** 48.982 (4) (a) of the statutes is amended to read:

15 48.982 (4) (a) From the appropriations under s. 20.433 (1) (c), (h), (i), (k), (m)
16 and (q), the board shall award grants to organizations in accordance with the plan
17 developed under sub. (2) (a). In each of the first 2 fiscal years in which grants are
18 awarded, no organization may receive a grant or grants totaling more than \$15,000.

19 **SECTION 32f.** 48.982 (5) of the statutes is amended to read:

20 48.982 (5) STATEWIDE PROJECTS. From the appropriations under s. 20.433 (1) (c),
21 (i) and (r), the board shall administer any statewide project for which it has accepted
22 money under sub. (2m) (c).

23 **SECTION 32g.** 48.982 (6) (a) of the statutes is amended to read:

1 48.982 (6) (a) From the appropriations under s. 20.433 (1) (b), (c), (h), (i), (k),
2 (ma) and (q), the board shall award grants to organizations in accordance with the
3 request-for-proposal procedures developed under sub. (2) (a). No organization may
4 receive a grant or grants under this subsection totaling more than \$75,000 in any
5 year.

6 **SECTION 32h.** 48.982 (7) (a) of the statutes is amended to read:

7 48.982 (7) (a) From the appropriations under s. 20.433 (1) (c), (h), (i), (k) and
8 (q), the board shall award grants to organizations in accordance with the plan
9 developed under sub. (2) (a).”.

10 **5.** Page 44, line 19: delete lines 19 to 23.

11 **6.** Page 138, line 7: after that line insert:

12 “(2g) CHILD ABUSE AND NEGLECT PREVENTION FUNDING. Notwithstanding section
13 20.002 (1) of the statutes, if the biennial budget act for the biennium beginning July
14 1, 1999, is not enacted on or before June 30, 1999, moneys encumbered or expended
15 from the appropriation accounts under sections 20.433 (1) (c) and 20.435 (3) (b) of the
16 statutes, as amended by this act, may not exceed, for each month beginning July 1,
17 1999, until enactment of the biennial budget, an amount equal to one-sixth the
18 amount of the money that was authorized to be encumbered and expended from the
19 appropriation accounts from January 1, 1999, to June 30, 1999.”.

20 **7.** Page 140, line 14: after that line insert:

21 “(1x) CHILD ABUSE AND NEGLECT PREVENTION; FISCAL YEAR 1998-99 FUNDING. The
22 creation of sections 20.433 (1) (c) and 20.435 (3) (b) of the statutes takes effect on
23 January 1, 1999.
