Dear Speaker Brancel:

**Assembly Bill 61**, introduced by Representative Scott Gunderson, relates to hunting and fishing fees. I support the fee increases in this bill, which are vital for the continuation of Wisconsin's fish and hunting programs.

**Assembly Bill 61** contains a fiscal note in excess of \$100,000. Pursuant to sec. 16.47(2), Stats., I consider this bill an emergency bill and ask that passage of **Assembly Bill 61** be permitted prior to passage of the budget bill. If this legislation is not enacted by March 1, 1997, additional reductions in fish and hunting programs will have to be realized.
