#### **Assembly Bill 650**

Relating to: restrictions on payment for abortions with public funds; changing the prohibition on use of federal, state or local funds for abortion-related activities by a pregnancy program, project or service; exempting the sales of flex-time time-share property from the sales tax and imposing the real estate transfer fee on all sales of time-share property; the penalty provision for premature sales or transfers of business assets or assets used in farming that were received from family members; pregnancy as a preexisting condition; transfers from the segregated transportation fund to the segregated transportation infrastructure loan fund, and the transportation infrastructure loan program; changing conflict of interest provisions and lottery participation restrictions that affect certain employes of the department of revenue; the indexing of the mining tax; criminal history and abuse record searches of persons applying to the department of health and family services for a license, certification or registration to operate certain entities that care for children or adults and of employes, prospective employes, adult residents and prospective adult residents of those entities; copayments under the medical assistance program for specialized medical vehicle services; the delegation of authority by local units of government over funds held in trust for certain pension plans; the transportation and sale of fish; restrictions on the placement of sexually violent persons who are granted supervised release; eliminating cross-references to the Wisconsin works health plan; tax increment sharing for tax incremental financing districts in Oshkosh that contain polluted soil; specific information signs along STH 172; weight limitations for vehicles and combinations of vehicles transporting bulk potatoes; grants awarded by the environmental education board that are related to forestry; provision of information necessary for the administration of child support and economic support programs; and making an appropriation.

Relating to: suspension of licenses, permits and other credentials for failure to pay child support or to comply with a subpoena or warrant related to paternity or child support proceedings and requiring social security numbers on license, permit and other credential applications and on certain documents concerning marriage and children; creating a record matching program to match information about delinquent child support obligors with financial account information of financial institutions; creating a statutory lien for delinquent child support obligations; creating a mechanism for enforcing child support liens; fees for the child and spousal support, establishment of paternity and medical liability support program and cooperation with child support efforts under Wisconsin works; income withholding for support or maintenance, adjudicating paternity when the mother fails to appear and other technical changes related to child support enforcement; access to certain agency records, nonliability for providing information from records, issuing subpoenas, ordering genetic tests; providing notice to new employers of a parent's obligation to provide health care coverage for a child; hospital-based voluntary establishment administratively paternity; changing income-withholding orders to sum certain amounts: presumption of paternity; access by county child support employes to tax information; acknowledgment of paternity; procedure, temporary orders and probable cause in paternity actions; payment for genetic tests in paternity actions; changes in departmental responsibility for support enforcement; intercepting delinquent support and certain other payments from pension plan disbursements; intercepting delinquent support from court judgments and settlements; granting rule-making authority; making appropriations; and providing a penalty.

To the Honorable, the Legislature:

This report is transmitted as required by sec.20.002(11)(f) of the Wisconsin Statutes, (for distribution to the appropriate standing committees under sec. 13.172(3) Stats.), and confirms that the Department of Administration has found it necessary to exercise the temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative balances during the month of October, 1997.

On October 20, 1997 the <u>Wisconsin Petroleum Inspection</u> Fund balance was -\$1.52 million. This shortfall continued until October 21, 1997 when the balance reached \$7.24 million. This shortfall was due to the timing of revenues.

On October 2, 1997 the Wisconsin Health Education Loan Repayment Fund balance was -\$1 thousand. This shortfall continued through the end of the month. This shortfall was due to the timing of revenues.

The Wisconsin Petroleum Inspection Fund and Wisconsin Health Education Loan Repayment Fund shortfalls were not in excess of the \$400 million ceiling and did not exceed the balances of the Funds available for interfund borrowing.

The distribution of interest earnings to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by the State Controller's Office will automatically reflect the use of these temporary reallocations of balance authority.
