EXECUTIVE COMMUNICATIONS

Executive Order Number 332

Relating to Amending Executive Order No. 329

I, TOMMY G. THOMPSON, Governor of the State of Wisconsin, pursuant to Article IV, Section 11 and Article V, section 4 of the Wisconsin Constitution, do hereby amend Executive Order No. 329 and require the Legislature to consider and act upon the following legislation in addition to the legislation set forth in Executive Order No. 329, as amended:

9. Legislation relating to the method of election of members of the board of school directors in 1st class city school systems; contract negotiation meetings between a board of school directors for a 1st class city school system and any labor organization recognized or certified to represent school district professional employes under the municipal employment relations act; reorganizing schools in a 1st class city school system and prohibiting collective bargaining with respect to reassignment of employes of a 1st class city school system; conversion of private schools to charter schools; educational service contracts between the board of school directors for a 1st class city school system and private schools and agencies; measuring whether schools in the Milwaukee Public Schools meet certain education criteria; creating local reform councils for certain schools in the Milwaukee Public Schools; the use of intradistrict transfer aid to build or lease neighborhood schools; contracts with the Boys and Girls Clubs of Greater Milwaukee to improve attendance at selected schools; aid to the Milwaukee Public Schools for after-school programs; aid to the Milwaukee Public Schools for summer school; achievement guarantee contracts for the Milwaukee Public Schools; and making appropriations.

RULING ON THE POINT OF ORDER

Speaker Jensen ruled **not well taken** the point of order raised by Representative Krug that Assembly substitute amendment 1 to **Senate Bill 2**, April 1998 Special Session was not germane under Assembly Rule 54(3)(f).

The lady from the 12th and the gentleman from the 7th have asserted that the proposal is not germane on the grounds that the proposal substantially expands the scope of the proposal.

The proposed substitute amendment, Assembly Substitute Amendment 1 to Special Session Senate Bill 2, proposes to make various changes to the statutes governing the public school system in a 1st class city. One provision in the relating clause provides that this proposal relates to "reorganizing" schools in first class cities. It could be argued that this provision only narrows the scope of this proposal and provides for a particularized detail (by providing for the creation of a commission and the placement of certain referendum questions concerning the reorganization of schools in first class cities in the spring, 1999 election). In addition, both the original bill and the proposed substitute have appropriations. This amendment is clearly germane under Assembly Rule 54(4).
