

1997 ASSEMBLY JOINT RESOLUTION 42

1 **Relating to:** memorializing Congress to fully fund the federal share of state

- 2 veterans homes construction projects.
- 3 Whereas, the state veterans homes were founded for Civil War veterans in the
- 4 late 1800's and have served veterans for over 100 years; and
- 5 Whereas, under the provisions of Title 38 of the United States Code, the U.S.
- 6 Department of Veterans Affairs is authorized to make aid payments to states 7 maintaining state veterans homes, subject to the provisions of the Code of Federal
- 8 Regulations, 38 CFR 18.1 through 18.3; and
- 9 Whereas, there are 87 state veterans home care facilities in 42 states
 10 throughout the United States, with more being added annually; and
- 11 Whereas, the state veterans homes program has proven to be a cost-effective 12 provider of quality care services to the nation's veterans who require domiciliary, 13 nursing home and hospital care; and
- Whereas, the U.S. Department of Veterans Affairs promotes the care and treatment of veterans in state veterans homes as a means to attain the goal of developing and maintaining the highest possible quality of patient care for eligible veterans; and

Whereas, the state veterans homes construction grant program is funded at
 65% of total cost; and

Whereas, the U.S. Department of Veterans Affairs has not kept pace with state
veterans homes applications for new construction projects. Currently, an unfunded
balance of over \$200,000,000 exists; and

6 Whereas, the state veterans homes program is recognized as the lowest cost
7 alternative among all nursing care alternatives used by the U.S. Department of
8 Veterans Affairs; and

9 Whereas, given the growing long-term health care needs of older veterans, the 10 state veterans homes program will continue to be a vital health care provider and the 11 lowest cost alternative for veterans needing long-term nursing care; now, therefore, 12 be it

Resolved by the assembly, the senate concurring, That the members of the
 Wisconsin legislature urge Congress to appropriate the money necessary to fully
 fund the federal share of state veterans homes construction project requests for fiscal
 year 1998; and, be it further

Resolved, That the assembly chief clerk shall provide a copy of this joint
resolution to the President of the United States, to the secretary of the U.S.
Department of Veterans Affairs and to each member of this state's congressional
delegation.
