If you are unable to attend, please feel free to send a staff person in your place.

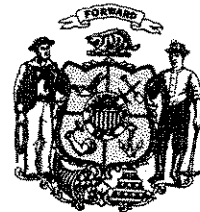

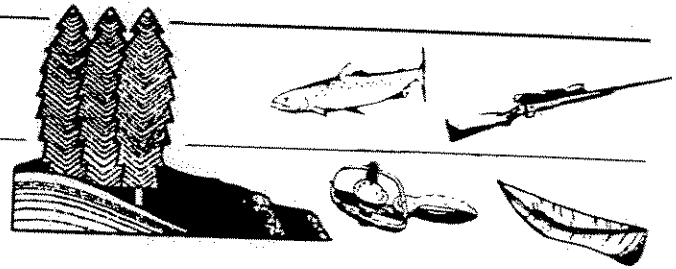

Dear Mr. Ulrich:

I am writing to formally request the presence of the EPA representative you deem appropriate to appear at a hearing before the Wisconsin Assembly's Environment Committee on December 15. I have been informed that Michelle Farley and Cynthia Kawakami of your office would be attending. The two portions of the hearing where EPA knowledge could be beneficial include:

Invited speakers including Lloyd Eagan, Director of the DNR Bureau of Air Management, and speakers from the EPA Region V office will provide a briefing on the Environmental Protection Agency's NOx State Implementation Plan and how it affects the State of Wisconsin. Commissioner Joseph Mettner of the Public Service Commission has also been invited.

The Committee will also make an informational inquiry into NR 415.04 and NR 431.05, relating to the issue of particulate emissions arising from farming operations.

Wisconsin NR 415.04 relates to fugitive dust. Specific questions could involve the intent of the Clean Air Act and how it specifically authorizes states rulemaking to regulate a variety of activities such as farming, grain handling and maintaining roads.

A copy of the hearing notice is enclosed.

This is an informational hearing and the committee will not be voting on these issues on this day.

I strongly believe that the presence of EPA staff will help us to understand state and federal roles in these important issues. I look forward to hearing from you on the availability of staff to represent the EPA at this hearing.
