



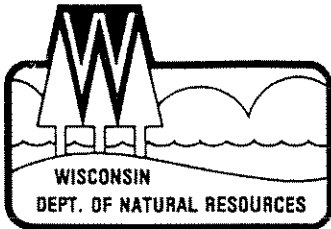

SUBJECT: SKI TEAM PERMIT APPLICATIONS

Dear Mr. Winzenried:

Thank You for writing to me with your letter about this application. We have received several letters that express similar concerns and objections about the permitting of these ski jumps and performance platform. This letter serves to summarize the permitting process and also to clarify a few points.

Before discussing the details of the permit process, if you ever have any questions or comments please feel free to contact me at (715) 856-9160. I am willing to meet with you personally to discuss this further, please feel free to call me to arrange a meeting if you would like that.

You specifically state that you object to the application and are willing to state your objections at a contested case hearing. Therefore, we can not grant this permit and we are required to refer it to a contested case hearing. At this hearing, both sides will be able to offer evidence supporting their positions and an Administrative Law Judge will review the testimony and render a decision.

Listed below are some issues that I would like you to respond to. I have numbered them accordingly.

1. \$25.00 fee: I accidentally omitted some language from the public notice that I sent to you regarding fees for hearings. We are now required to charge a fee for requests for contested case hearings. Enclosed is a fee sheet. Please fill out this sheet and submit it to me with the mandatory fee of \$25.00. If I do not receive this fee, I will not forward your objection to a contested case hearing and we may be able to issue the permit without having a hearing. Therefore, if you want this referred to a hearing, you must submit the fee.

2. Modifications to Application: We recently met with the Crivitz Ski Cats and explained to them that we have received many letters of objection regarding these applications. We asked the Crivitz Ski Cats to modify their application so that the objections will be properly addressed. Enclosed you will find a copy of their response on how they propose to place and use the 2 ski jumps and the 1 performance platform. Please read this modification and let me know if it changes your objection. Do you have any suggestions as to what the ski team could do to modify these applications so that this will not be objectionable to you?

3. Temporary Use of Ski Jumps and Performance Platform: In 1996, we allowed the ski team to place and use the ski jumps and performance platform in Lake Noquebay with the understanding that they would place these structures in the lake during the day and then remove them from the lake each night without a permit from us. Since then, the ski team has applied for permits from us to place these structures in the lake and we have received several objections. Legally, even a temporary structure is a structure that requires a permit under section 30.12 Wisconsin Statutes. Standard practice is that where someone has objected to a structure and a permit is required, the structure cannot be placed until the issues are resolved after the hearing. Do you object to the placement of the ski jumps and performance platform in the lake, even on a temporary basis, before the permit application has been resolved?

For your information, we are required by State law to review permit applications such as these and may only grant permits for these structures that meet the following criteria. The ski jumps and performance platform must not materially obstruct navigation, reduce the flood flow capacity of a stream, or be detrimental to the public interest. The public interest include issues such as natural scenic beauty, fish and wildlife habitat, recreation, and water quality. Permit applications are resolved by one of the following scenarios:

*If there are no objections to a permit application, we can issue the permit.

*If there are objections but no one is willing to state their objections at a hearing, then we will take those objections as advisory and may still be able to legally issue the permit.

*If there are objections and the objectors are willing to state their objections, we cannot deny the permit but must refer it to a contested case hearing. As stated above, at the hearing the Administrative Law Judge determines the outcome of the permit application.

Please respond to the 3 items listed above and provide a response to me by May 19, 1997, 1997. If you need more time to evaluate this information, please let me know and an extension can be granted.

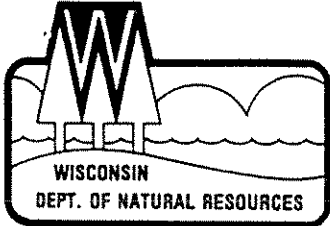

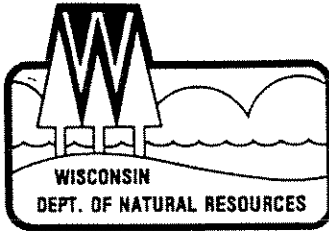

Subject: Response to Ski Team Permit Application Letter Dated April 22, 1997

This letter outlines my response to your letter. This letter had three items to respond to and they are as follows;

- 1) **\$25.00 fee:** I agree to pay the fee to request for contested case hearing. The check for \$25.00 is attached.
- 2) **Modifications to Application:** The letter from the Ski Cats proposes vague guarantees to potentially reduce the concerns of the neighbors. We have attempted in 1996 to reach a consensus to issues raised by the Lake Noquebay property owners by meeting with the Ski Cats. The experience of the owners after the meeting with the conduct of the Ski Cats in 1996 season was a realization that what the Ski Cats said they would do to guarantee proper conduct to eliminate the Lake property owner's concerns were never applied. Also, the promises to the Department of Natural Resources were not applied, based on public records of letters sent to the Ski Cats and complaints filed by property owners. Therefore, based on the 1996 experience we have limited faith the Ski Cats will adhere to their proposed vague guarantees. Let me quote "A promise made, is a debt unpaid". These modifications will not satisfy the concerns filed with the DNR.


My comments to the letter from the Ski Cats are as follows:

- 1) A history of the Ski Cats is irrelevant. If this were a new ski team applying to use Lake Noquebay in this new time of the 1990's where lake property owners are retiring and living year round on the lake, the quantity of people enjoying the lake and the quantity of homes occupying the shore line, they would not be granted use of the lake. Times have changed. I disagree with the statement that the inconvenience of the neighbors is due to the movement of the ski jump and the performance platform. It is NOT the movement of the objects, it is the constant use of the lake for practices and shows and the objects in the water are impacting the environment and public use of the lake. The attitude of this statement shows an arrogant attitude with respect for the lake and is an attempt to trivialize our concerns for the environment and public access rights of the lake.
- 2) Our experience with the Ski Cats use of the lake is much more than 15 hours per week. If the Ski Cats were limited to 15 hours per week, based on current usage they would be on the lake for less than two days. The comment of less than 1/2 of one percent being used is incorrect. Not all 2200 acres can be used for skiing. The utilization of the lake will INCREASE due to the use of the two proposed ski jumps and the traffic created when moving between both jumps. All bullets in item two are minor changes based on trust that the Ski Cats will do what they say. As stated before, our experiences in trusting the Ski Cats is diminished.

- 3) **Temporary use of Ski Jumps and Performance Platform:** I disagree in allowing the Ski Cats temporary use of the objects and to move the objects in and out as needed. The 1996 Ski Cat season provide the experience to the owners that the platform and jump create a negative impact to the community and environment. Therefore, object to the placement of the ski jumps and performance platform in the lake, even on a temporary basis, before the permit application has been resolved.

Dear Mr. Rosenberger,

We support the Crivitz Ski Cats and believe they should be able to operate both ski jumps along with other equipment that they believe necessary for the operation of their club.

People who object to their ski jumps are not really objecting to the jumps themselves. They object to water skiers in general and the jumps are only a vehicle for their unhappiness at having to share the lake with everyone.

Their complaint largely centers at wave action by boats and traffic near their docks.

The ski jumps have nothing to do with either one of these complaints. Less with jumping because the boat is fully planed at 32-35 mph- unlike some acts which may operate at 12-15 mph.

Traffic near docks is actually less with ski-jumpers because the jump is located farther out into the lake and the boat is much farther out in the lake than the 100 feet required by law.

My son is a jumper. Jumping is being proposed and considered as an Olympic sport in the next Olympics. My son has placed in two water ski Nationals and is rated in the top 2 or 3 jumpers in the Midwest - and yes- he does have Olympic aspirations. He has been told by many professional skiers that he has this potential.

This is why we purchased our lot on Lake Noquebay. Without a jump to practice on his dreams and his potential cannot be realized.

I hope you realize the worthwhile activity you are denying the youth of this area.

I can't believe the D.N.R. will let a relatively few complaints deny the youth of the area this opportunity. Steve Day informed us that there was only one complaint about our jump on over 30 years of operation. That record speaks for itself. I can assure you that Public outcry is going to be loud on this issue. Hope you will reconsider your decision.

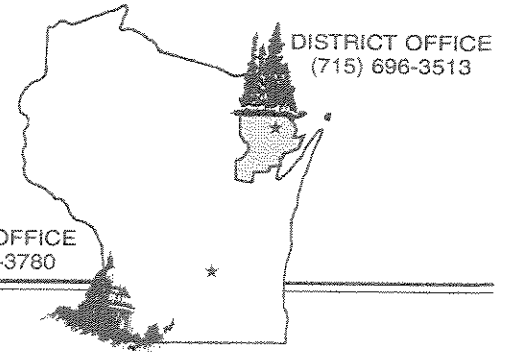




