

ASSEMBLY AMENDMENT, TO 1999 ASSEMBLY BILL 39

1	At the locations indicated, amend the bill as follows:
2	1. Page 1, line 4: before that line insert:
3	"Section lg. $\sqrt{196.795}$ (1) (h) 2. of the statutes is amended to read:
4	196.795 (1) (h) 2. "Holding company", except for purposes of s. 196.795 <u>(3)</u> and
5	(11) (b), does not mean any company which owns, operates, manages or controls a
6	telecommunications utility, unless such company also owns, operates, manages or
7	controls a public utility which is not a telecommunications utility".
