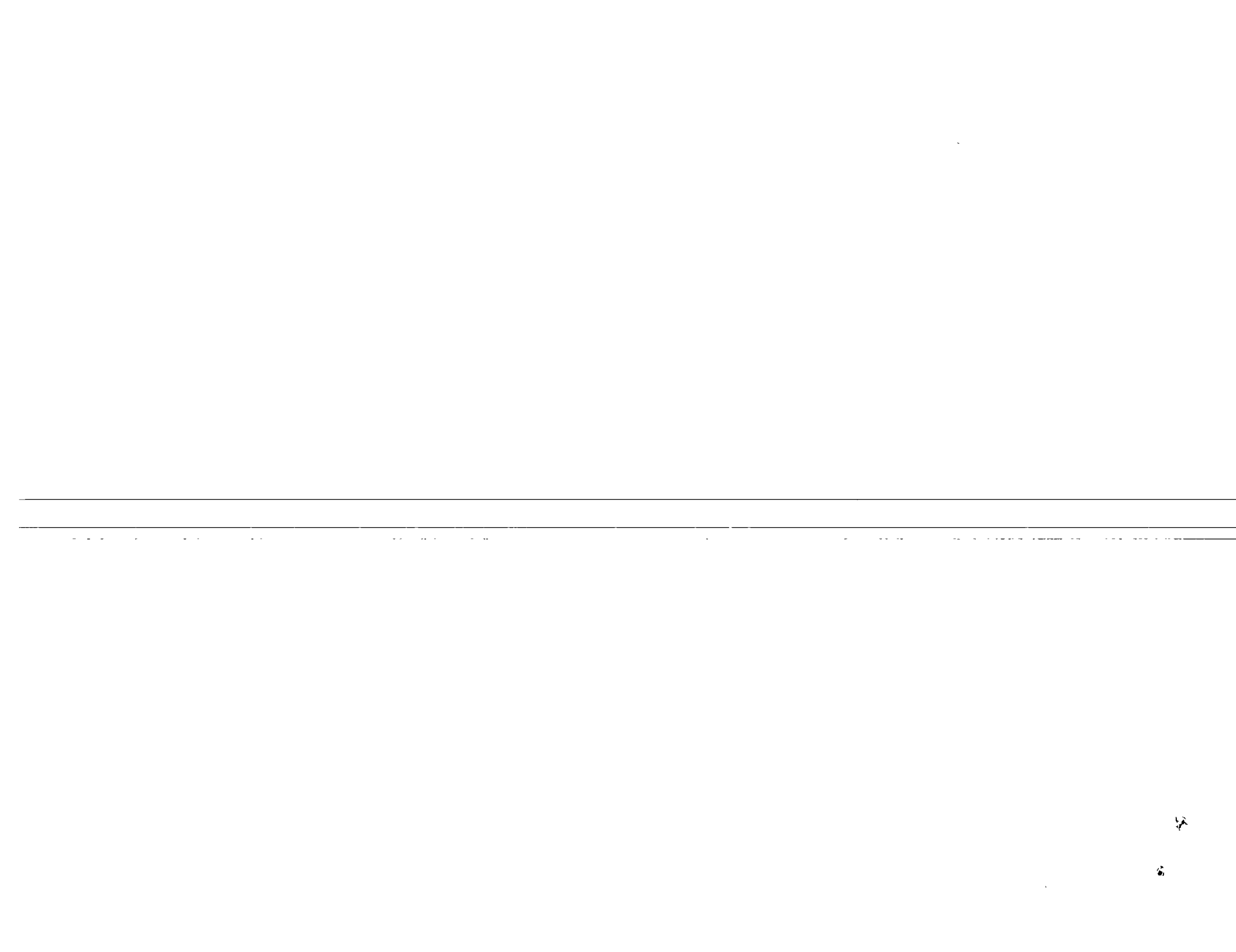

1. Page 2, line 12:

SECTION 5g. CR. 165.72 (2e)

165.72 sub (2e) Emergency Calls. If the department of justice receives information under sub. (2c) regarding dangerous weapons in a public school and the situation appears to be an emergency, the department shall tell the caller to notify their local law enforcement or call 911."
