1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 6: after that line insert:

3 "SECTION 1m. 77.79 of the statutes is amended to read:

4 **77.79 Relation to subchapter subch. III.** The provisions of subch. III;
5 including those related to exemptions, exceptions, exclusions and the retailers'
6 discount; that are consistent with this subchapter, as they apply to the taxes under
7 that subchapter, apply to the taxes under this subchapter, except that the exemption
8 under s. 77.54 (44) does not apply to the taxes imposed under this subchapter unless
9 a county enacts an ordinance ^{subject to s. 77.70,} or a local professional baseball park district adopts a
10 resolution ^{subject to s. 77.70,} which applies that exemption to the taxes that are imposed under this
11 subchapter."
