**ASSEMBLY AMENDMENT ,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO 1999 ASSEMBLY BILL 51**

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 6, line 18: after "Each authority" insert "which is authorized to collect  
3 information under sub. (2m)".

4 **2.** Page 6, line 23: after that line insert:

5 **"(2m) (a)** No authority may require the submission of information relating to  
6 year 2000 processing under sub. (2) without authorization from the secretary of  
7 administration.

8 (b) The secretary of administration may authorize an authority to collect  
9 information relating to year 2000 processing upon making a finding that it is  
10 necessary to protect public health and safety.

11 (c) Each authority seeking authorization from the secretary of administration  
12 shall submit a written request to the department of administration specifying any

1 entities from whom information is sought and showing how the collection of  
2 information relating to year 2000 processing by that authority is necessary to the  
3 exercise of the authority's regulatory power relating to protecting public health or  
4 safety.

5 (d) The department of administration shall appoint an advisory committee to  
6 review requests for authorization under this subsection and make recommendations  
7 thereon to the secretary of administration. The advisory committee shall include  
8 representatives from regulated businesses and individuals with expertise in year  
9 2000 processing.

10 (d) ~~(e)~~ The secretary of administration shall approve or disapprove each request  
11 submitted under par. (c) within <sup>10</sup>30 days of submittal of the request.”

12 **3.** Page 7, line 15: after that line insert:

13 “(5) No authority may request information under sub. (2) after January 1,  
14 2000.”.
