

- 1 At the locations indicated, amend the substitute amendment as follows:
 - 1. Page 4, line 22: delete lines 22 to 24 and substitute:
- 3 "1. If, in addition to the licensee, the vehicle is occupied by any person other than the following:
 - a. Any number of members of the licensee's immediate family.
 - b. A person who meets the requirements under s. 343.07 (1) (a).
 - c. person not described in subd. 1. a. and b.".
