3 2. Page 4, line 7: delete that line.

4 3. Page 4, line 8: delete "786.36 (2) (b)" and substitute "2."

5 4. Page 4, line 13: after that line insert:

6 "3. Before changing the name of a minor who is 12 years of age or over, the court
7 shall address the minor to determine the wishes of the minor with respect to the
8 proposed name change and shall consider those wishes in determining whether to
9 order the name change."
