TO 1999 ASSEMBLY BILL 79

1 At the locations indicated, amend the bill as follows:

2 1. Page 4, line 5: delete "urinates, defecates or expectorates upon a flag" and
3 substitute "causes a flag to come into contact with urine, feces or excretion".

4 2. Page 5, line 10: ~~on lines 10 and 11~~, delete "urination, defecation or"
5 expectoration upon a flag" and substitute "causing a flag to come into contact with
6 urine, feces or excretion".

7 3. Page 5, line 22: ~~on lines 22 and 23~~, delete "urinates, defecates or"
8 "expectorates upon a flag," and substitute "causes a flag to come into contact with
9 urine, feces or excretion,".
