TO 1999 ASSEMBLY BILL 79**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: delete "certain".

3 **2.** Page 1, line 5: delete "flags" and substitute "the U.S. flag".

4 **3.** Page 3, line 5: delete "OR STATE".

5 **4.** Page 3, line 12: delete "and the Wisconsin state flag".

6 **5.** Page 3, line 13: delete "those flags to the nation and the state," and
7 substitute "the flag to the nation,".

8 **6.** Page 5, line 16: delete lines 16 and 17 and substitute "**destroying a U.S.**
9 **flag.** (1) In this section, "flag" means a flag of the United States consisting of
10 horizontal stripes, alternately".

11 **7.** Page 5, line 19: delete lines 19 to 21.
