TO 1999 ASSEMBLY BILL 79

1 At the locations indicated, amend the bill<sup>✓</sup> as follows:

2 1. Page 3, line 1: delete lines 1 to 3 and substitute:

3 "SECTION 1g.<sup>✓</sup> 895.75 (1)<sup>✗</sup> of the statutes is amended to read:

4 895.75 (1) ~~Any~~ If a person ~~who~~ suffers physical injury to his or her person or  
5 emotional distress or damage to or loss of his or her property by reason of conduct  
6 ~~which that~~ is prohibited under s. 943.012 and that causes damage to any property  
7 specified in s. 943.012 (1) to (4)<sup>✓</sup> or which by reason of conduct that is grounds for a  
8 penalty increase under s. 939.645 (1)<sup>✓</sup>, the person has a civil cause of action against  
9 the person who caused the physical injury, emotional distress, damage or loss."
