

I am requesting an amendment to Section 6 of AB 94. The amendment should change the created ss 118.33 (6) (a) to read:

Each school board shall adopt a written policy specifying the criteria for promoting a pupil from the 4<sup>th</sup> grade to the 5<sup>th</sup> grade and from the 8<sup>th</sup> grade to the 9<sup>th</sup> grade. The criteria shall include the pupil's score on the examination administered under s. 118.30 (1m) (a) or (am), the recommendation of the pupil's teachers based on the pupil's academic performance, and any other academic criteria specified by the school board.
