1 **AN ACT to amend 118.12 (1); and to create 118.12 (1) (c) of the statutes; relating**
2 **to: prohibiting school boards from entering into certain contracts.**

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 118.12 (1) of the statutes is amended to read:

4 118.12 (1) (a) Except as provided under ~~par.~~ pars. (b) and (c), any person may
5 sell or promote the sale of goods or services on school district or cooperative
6 educational service agency property.

7 (b) ~~A. Subject to par. (c),~~ a school board may adopt written resolutions governing
8 the sale and promotion of goods and services on school district property. The board
9 of control of a cooperative educational service agency may adopt written resolutions
10 governing the sale and promotion of goods and services on agency property. The
11 resolutions may prohibit, restrict or provide guidelines for such sales and
12 promotions.

1 SECTION 2. 118.12 (1) (c) of the statutes is created to read:

2 118.12 (1) (c) No school board may do any of the following:

3 1. Enter into a contract that prohibits the school board, a school board member,
4 a school district employe or a pupil from disparaging the goods or services of the
5 person contracting with the school board.

6 2. Enter into a contract that requires the dissemination of advertising to pupils.

7 **SECTION 3. Initial applicability.**

8 (1) This act first applies to contracts entered into, modified, extended or
9 renewed on the effective date of this subsection.

3. Enter into a contract that grants the right to advertise or sell a particular good or service unless the school board holds a public hearing on the proposed contract.
