1 AN ACT to amend 118.12(1); and to create 118.12(1)(c) of the statutes; relating
2 to: prohibiting school boards from entering into certain contracts.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 118.12 (1) of the statutes is amended to read:

118.12 (1) (a) Except as provided under par. pars. (b) and (c), any person may sell or promote the sale of goods or services on school district or cooperative educational service agency property.

(b) A Subject to par. (c), a school board may adopt written resolutions governing the sale and promotion of goods and services on school district property. The board of control of a cooperative educational service agency may adopt written resolutions governing the sale and promotion of goods and services on agency property. The resolutions may prohibit, restrict or provide guidelines for such sales and promotions.
