

ASSEMBLY SUBSTITUTE AMENDMENT, TO 1999 ASSEMBLY BILL 169



AN ACT ...; relating to: domestic abuse and providing a penalty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. 939.6215 of the statutes is created to read:

939.6215 Increased penalty for committing battery in the presence of a child. (1) If an adult person is convicted of a crime specified in s. 940.19 (2) to (6), 940.20 (1m) or 940.201, the maximum term of imprisonment for the crime may be increased by not more than 5 years if all of the following apply:

(a) The conduct constituting the crime involved an act by the adult person against his or her spouse or former spouse, against an adult with whom the adult person resides or formerly resided or against an adult with whom the adult person has a child in common.

Section 4. 939.6215 (2) of the statutes, as created by 1999 Wisconsin Act 1 $\mathbf{2}$ (this act), is repealed. Section 5. Nonstatutory provisions. 3 (1) RECONCILIATION PROVISION. The repeal of section 939.6215 (2) of the statutes, 4 as created by this act, the renumbering and amendment of section 939.6215 (title) 5 and (1) of the statutes, as created by this act, and SECTION 6 (1), (2) and (3) of this act 6 are void unless 1999 Assembly Bill 465 is enacted into law before July 1, 2000, and 7 unless 1999 Assembly Bill 465 creates section 973.017 of the statutes in exactly the 8 same form as it appears in section 757 of 1999 Assembly Bill 465. 9 SECTION 6.
