

Provide \$2 million GPR in FY00 and \$4 million GPR in FY01 in increased youth aids to counties to cover the cost increases associated with operating the state juvenile correctional institutions.

Additionally, the Governor's budget includes more funding for offender programming and work opportunities, offender tracking and supervision, and crime victim services. Specifically, the Governor's budget includes the following provisions:

- Provide \$113,000 GPR in FY00 and \$140,000 GPR in FY01 and 2.0 FTE GPR positions to ensure that DOC has sufficient resources for the sex offender registry program and provide \$139,600 GPR in FY00 and \$147,100 GPR and 2.0 FTE GPR positions for the DOC sex predator evaluation unit. Providing these resources will ensure continued public safety and full implementation of Wisconsin's sex predator law.
- Provide \$1,304,600 GPR in FY00 and 40.0 FTE GPR positions and \$3,085,800 GPR in FY01 and 40.0 FTE GPR to operate two 150-bed work units for male inmates. Inmates housed in these secure facilities will be connected with market-wage paying jobs and will be expected to reimburse DOC for the cost of their housing and other expenses.
- Provide \$1 million PR-S annually in anti-drug funds, administered by the Office of Justice Assistance, for alcohol and drug abuse programming and treatment and over \$394,000 GPR biennially for additional sex offender programming.
- Create an Office of Victim Services in DOC to assist crime victims and respond to victim requests regarding offender status.
- Prohibit the Department of Corrections from entering into a contract in which a prisoner would perform data entry or telemarketing services and have access to an individual's credit card, checking, savings account or social security numbers, or any information that may serve to identify a minor.

COMPRECIONAL SYSPEM
AND TOOKUROLON LESSEM

This bill provides that the department of corrections (DOC) may not enter into any contract or other agreement if, in the performance of the contract or agreement, a prisoner would perform data entry or telemarketing services and have access to any information that may serve to identify a minor.

In addition, the bill provides that DOC may not enter into any contract or other agreement if, in the performance of the contract or agreement, a prisoner would perform data entry or telemarketing services and have access to an individual's financial transaction card numbers, checking or savings account numbers or social security number. Under the bill, a financial transaction card means an instrument or device issued for the use of the cardholder in obtaining anything on credit, certifying or guaranteeing the availability of funds sufficient to honor a draft or check or gaining access to an account.
