Analysis by the Legislative Reference Bureau

Under current law, a charter school is exempt from most laws governing public schools. A charter school may be established by filing a petition with a school district requesting the school board to enter into a contract with ~~an individual or group~~ to establish and operate a charter school or by a school board's initiating such a contract. In addition, current law authorizes ~~2 Milwaukee entities,~~ the city of Milwaukee, the University of Wisconsin-Milwaukee and the Milwaukee Area Technical College, to initiate a contract with an individual or group to operate a school as a charter school or to establish and independently operate charter schools. A pupil residing in the Milwaukee public school district may attend a charter school established by one of the Milwaukee entities only if, in the previous school year, one of the following applied:

1. The pupil was enrolled in the Milwaukee public schools.
2. The pupil was attending a private school under the Milwaukee parental choice program.
3. The pupil was enrolled in grades kindergarten to 3 in a private school, located in the city of Milwaukee, other than under the Milwaukee parental choice program.
4. The pupil was not enrolled in school.

5. The pupil was enrolled in a charter school established by one of the Milwaukee entities.

Beginning in the ~~1998-99~~ school year, this bill allows a pupil who was attending a private school located in the city of Milwaukee, regardless of the grade attended or whether the private school was participating in the Milwaukee parental choice program, to attend a charter school established by one of the Milwaukee entities.

For further information see the state **and local** fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 118.40 (2r) (c) 2^v of the statutes -

~~is~~ is amended to read:

118.40 (2r) (c) 2. In the previous school year, the pupil was attending a private school ~~under s. 119.23~~ located in the city of Milwaukee.

SECTION 2. 118.40 (2r) (c) 3^v of the statutes @

~~is~~ is repealed.

SECTION 3. Initial applicability.

(1) This act first applies to pupils attending charter schools in the ~~1998-99~~ school year.

SECTION 4. Effective date.

(1) This act takes effect on July 1, ~~1998~~ 2000.

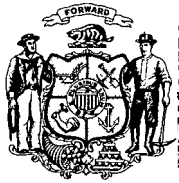
