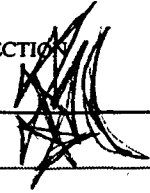

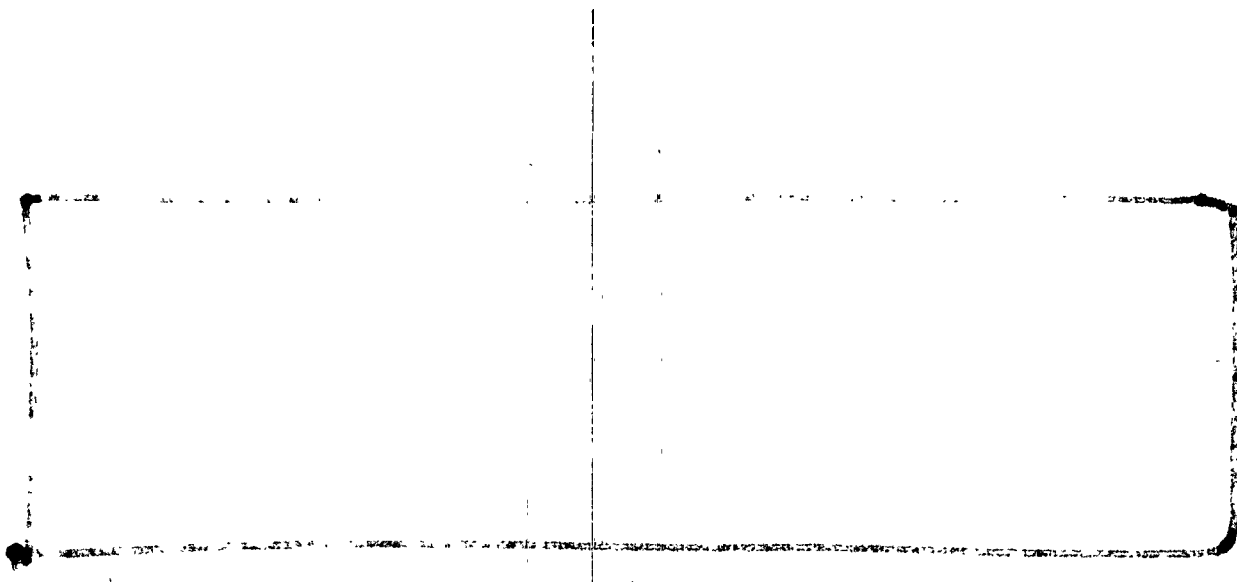

1 AN **ACT** relating to: achievement guarantee contracts and granting

Analysis by the Legislative Reference Bureau

Under current law, a school board with a certain percentage of low-income pupil enrollment in the previous school year may enter into a five-year guarantee contract with the department of public instruction to reduce class size and improve academic achievement in grades kindergarten to three! Class size is defined as the number of pupils assigned to a regular classroom teacher on the ~~2nd~~ ^{third} Friday of September. This bill defines class size as the number of pupils assigned to a regular classroom teacher or teacher aide on the ~~2nd~~ ^{third} Friday of September. ~~third~~
