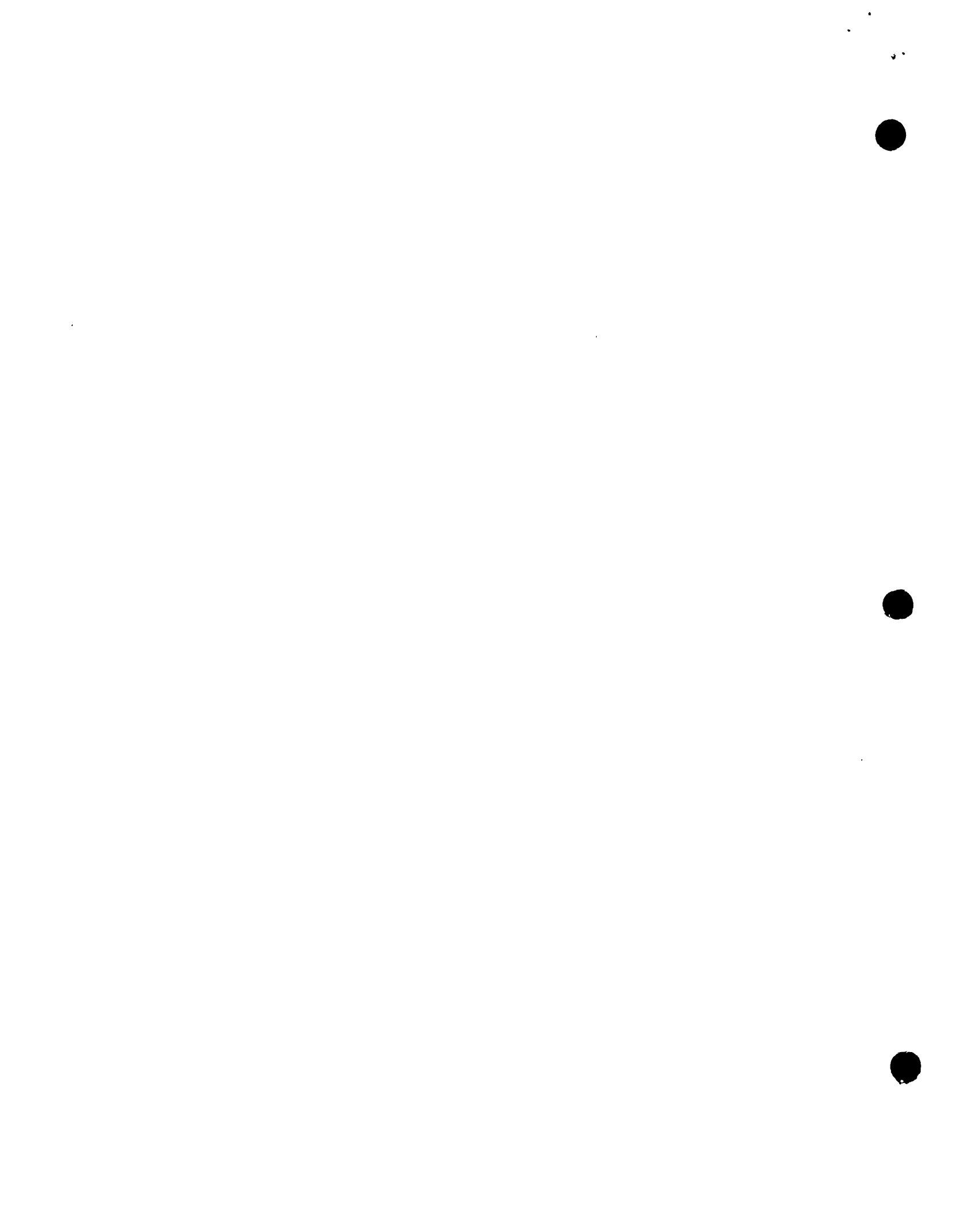

1           **814.632 Fees for judge substitution.** (1) The clerk of circuit court shall  
2 charge and collect a fee of \$32 from each person who requests the substitution of a  
3 judge under s. 48.29, 345.315, 799.205, 800.05, 801.58, 938.29 or 971.20.

4           (2) The clerk shall pay the moneys collected under sub. (1) to the county  
5 treasurer under s. 59.40 (2) (r). The county treasurer shall pay the moneys to the  
6 state treasurer under s. 59.25 (3) (u).".
