2 1. Page 10, line 23: after "activity" insert ", including refusing or stating an
3 intention to refuse to transfer a patient to another physician who will comply with
4 a declaration, as defined in s. 154.02 (1),[✓] instrument for power of attorney for health
5 care, as defined in s. 155.01 (10),[✓] or health care decision, as defined in s. 155.01 (5),[✓]
6 of a health care agent, as defined in s. 155.01 (4)".[✓]
