1 At the locations indicated, amend the bill as follows:

2 ✓ 1. Page 5, line 20: delete "A" and substitute "Subject to sub. (5), a".

3 ✓ 2. Page 7, line 4: delete "A" and substitute "Subject to sub. (5), a".

4 ✓ 3. Page 8, line 10: after that line insert:

5 "SECTION 12m. 253.09 (5) of the statutes is created to read:

6 253.09 (5) This section does not provide immunity to a health care provider, as
7 defined in s. 146.81 (1), if that health care provider refuses to provide a prenatal test
8 or procedure on moral or religious grounds, unless the health care provider gives
9 written notice of that refusal to all female patients for whom the test or procedure
10 might be appropriate."

11 ✓ 4. Page 8, line 15: delete "A" and substitute "Subject to par. (c), a".

12 ✓ 5. Page 9, line 17: after that line insert:

13 "SECTION 16m. 441.06 (6) (c) of the statutes is created to read:

2 person refuses to provide a prenatal test or procedure on moral or religious grounds,

9 person refuses to provide a prenatal test or procedure on moral or religious grounds,
10 unless the person gives written notice of that refusal to all female patients for whom
11 the test or procedure might be appropriate.”
