**TO ASSEMBLY SUBSTITUTE AMENDMENT 1,**

**TO 1999 ASSEMBLY BILL 356**

1 At the locations indicated, amend the substitute amendment as follows:

~~LEGISLATIVE COUNCIL PREFATORY NOTE. This amendment clarifies the relation between stipulated penalties and other penalties for violation of a compliance schedule. It specifies that stipulated penalties will apply for a period of time, not more than 6 months, following the compliance schedule and that the state may commence a forfeiture action if the violation is not corrected by the end of that period.~~

3 ✓ 2. Page 7, line 3: after that line insert:

4 "(b) Stipulated penalties approved under par. (a) shall specify a period, not
